

Terms and Conditions
For
"The Year of Knowledge: Self-Paced Program"

This document constitutes the terms and conditions for participation in "The Year of Knowledge: Self-Paced Program" provided by Jannah Institute. Please read carefully before agreeing to the terms and conditions.

1. **Eligibility:** This course is for women only, age 15 years and above.
2. **Course Access:** The 60-week self-paced course will be available online and participants will receive 5 hours of content weekly*. These will be zoom recordings of the previous Year of Knowledge live course taught by Sh. Haifaa Younis. Lifetime access is granted to the registered participant for the life of the organization and program.
* Some weeks' content may be less than 5 hours when a review session is included.
3. **Course curriculum and Content:** The participants will receive recordings for the following courses:
 - Aqeedah
 - Qur'anic Sciences
 - Hadith
 - Fiqh (Islamic rulings)
 - TazkiyahThe lessons in the course are based on classical books written by classical scholars. These books are provided in PDF format, along with slides and notes. The course is taught in English.
4. **Live Group Q&A Sessions:** Six Live Group Q&A Sessions with the teachers are included in the course. Dates and times will be communicated via email.
5. **Tuition and Fees:** The tuition for the course is \$1,997, which is payable in full at the time of registration. The special early bird rate is \$1,797 (which is available for 1 week only).
6. **Withdrawal and Refunds:**
If a student wishes to withdraw from the course, a written request must be submitted to JI via email at financejannahinstitute@gmail.com
The refund policy is as follows:
 - You have one week after the course's release to request a full refund.
 - After one week of starting the course, the course is non refundable.
