## **LOCAL SERVICE PLAN #1**

### **STUDENT SERVICES PROGRAMS**

*\*\*Ontario School District has elected flow through dollars for services covered in LSP 1; unless otherwise stated in the description, Ontario services are not included in this cost breakdown.*

- **Special Education Teacher/Diagnostician/Evaluation Team Program/Autism Specialist**

This program provides for diagnostic/evaluation services as well as direct instructional services to students meeting Oregon eligibility criteria for special education (OAR 581-015-0051). ESD staff work cooperatively with LEA support staff in meeting the educational needs of these students. Additionally, services of a certified school psychologist are provided on a limited basis. This funding in conjunction with IDEA and contracted services provides for 3.0 FTE certified staff.

This program provides for autism diagnostic/evaluation and consultation services to students meeting Oregon eligibility criteria for special education (OAR 581-015-0051). ESD staff work cooperatively with LEA support staff in meeting the educational needs of these students. This funding provides for 1 FTE certified staff.

It is estimated that the program cost of the Special Education Teacher/Diagnostician/Evaluation Team/Autism Specialist Program for 2025-2026 will be approximately **\$230,181**.

- **Counselor Program**

This program provides assistance to local districts in the area of evaluations and counseling for students with identified handicaps as required in OAR 581-015-0051. This combination of funding from LSP 1, IDEA, and a purchased services contracts provides for 3.0 FTE certified staff. Services are directed toward student evaluation, supporting students with disabilities with behavior and emotional challenges, and providing assistance to school personnel.

It is estimated that the program cost of the counseling program for 2025-2026 will be approximately **\$254,000**.

- **Speech-Language Therapy Program**

This program provides for speech-language services to students meeting Oregon eligibility criteria as specified in OAR 581-015-0051. This includes students with disorders in articulation, voice, fluency and language. (Speech disorder refers to articulation, voice and/or fluency. A language disorder is the impairment, or disordered development, of understanding or expression of language.) This funding provides for 3.65 FTE certified staff and 3.4 FTE classified staff. Speech-Language Pathologists provide services for all school districts grades K-12 through this program.

It is estimated that the cost of Speech-Language Therapy services for 2025-2026 will be approximately **\$681,275**.

- **Occupational and Physical Therapy Program**

This program provides for Occupational Therapy and Physical Therapy services to students/children identified as orthopedically impaired (OAR 581-015-0051), as well as other children/students with disabilities as required. Services include screening, evaluation, therapy, and consultative services. Funding is a combination of resolution dollars and State Early Intervention/Early Childhood Special Education funds.

It is estimated that the cost of .60 FTE certified staff, 1.0 FTE classified staff and program costs of the Occupational and Physical Therapy services for 2025-2026 will be approximately **\$120,000**

- **Special Education Director/Office Support**

The Special Education Director and staff provide supervision of Special Education Programs/Staff/Services under resolution, district contracts and regional programs as well as support services and records management software. The Director provides services on behalf of small districts as Special Education Director.

It is estimated that the cost of the Special Education Director (1.0 FTE), office support (0.65 FTE), supplies, equipment and in-service for 2025-2026 will be approximately **\$220,000**

**The total Student Services Local Service Plan dollars for 2025-2026 is estimated at \$2,595,456**

## **LOCAL SERVICE PLAN #2**

### **SUPPORT SERVICES PROGRAMS**

- **Curriculum/Instructional Services Program/STEM Program**

This program provides for a Curriculum/Staff Development Director, STEM Coordinator and support staff for the schools in Malheur Region 14 providing leadership in the development/coordination of School Improvement Projects. This position assists school districts with monitoring and compliance requirements of ODE and NCLB. It also provides support and professional development for OAKS/SBAC assessment. The Director acts as the liaison between Oregon Department of Education and local districts, serves as a grant writer for curriculum projects, provides guidance and support for the development and administration of federal programs (i.e. Title IA, IIA, IID, IVA, VA, and REAP), and assists in the evaluation of small district's staff evaluations. In addition, the Director provides professional development for standards implementation, best practices in instructional strategies, curriculum mapping and alignment, and using data to inform instruction and to guide resource allocation. The director will act as the assessment, home school, and McKinney Vento coordinators.

The STEM Hub will provide support to component school districts through the Malheur Works, and technology innovated learning for elementary and middle school students. Poverty to Prosperity (P2P) is a regional collaborative between TVCC, Malheur ESD, Ontario School District, Nyssa School District, Adrian School District and Vale School District. Collectively, these 6 educational entities are supporting high school CTE students in Welding, Allied Health, Early Childhood, Phlebotomy and automated control systems. Students completing these programs graduate with a high school diploma and a pathways certificate in their chosen discipline. This is a community effort that anticipates the addition of several smaller peripheral school districts in the future.

It is estimated that the cost of the Curriculum/Instructional Services Program and STEM Hub for 2025-2026 will be approximately **\$858,044**

- **Egenuity/OdysseyWare/Learn 360/MyOn**

This service program provides partial cost for support for both programs. Each district is billed a percentage based on ADMw for Edgenuity and MyOn.com after Malheur ESD meets their financial obligation. Learn 360's annual membership is paid by Malheur ESD.

It is estimated that the program cost of the Edgenuity/Edynamic/Learn 360/MyOn.com for 2025-2026 will be approximately **\$91,044**

- **Career/Technical Education Program/TVT**

This program provides for a Regional Coordination and support staff that is responsible for developing and maintaining CTE programs in Malheur, Grant, Wallowa, Baker, Union and Harney county school districts (Agriculture, Business, Automotive and Construction). The Perkins Basic and Reserve grants are written and fiscally managed through this program; grant funds are then distributed to local school districts that operate an ODE approved program of study. In addition, assistance is given to local school districts with computer technology, Intermountain Technology services and tech planning. This also provides a \$60,000 transfer to TVT. (This may change depending on potential ODE CTE Coordinator funding).

It is estimated that the cost of the Career/Technical Education Program/TVT for 2025-2026 will be approximately **\$142,000**

- **Nyssa Preschool Classroom #2**

This program was requested on behalf of Nyssa due to the large increase in their enrollment as a direct result of the Nyssa Online School. The classroom will be housed at the Nyssa District Office building, it will be a Pyramid Model Enhanced mixed funded classroom. Staffing will consist of 1.0 FTE certified instructor and 2.0 classified instructional assistants.

It is estimated that the cost of the Nyssa Preschool Classroom for 2025-2026 will be approximately **\$220,000.**

**The total Support Services Local Service Plan dollars for 2025-2026 is estimated at \$858,044**

- **EI/ECSE Child Find Evaluations**

Services provided to the consortia include EI/ECSE Child Find Evaluations for **\$172,000.**

- **Water Testing/Substitute Maintenance**

Services provide for water testing and AESOP Substitute Maintenance. **\$6,000.**

**The total Management Services/Programs Local Service Plan dollars for 2025-2026 is estimated at \$178,000**

- b. IDEA/LD Consortium Funds – Local district consortium with federal funds to support Special Education in Adrian, Annex, Arock, Harper, Jordan Valley, Juntura, Vale, and Huntington. **\$266,500**
- c. Youth Transition Program – State grant dollars and local dollars provide services for Transition Specialists at High School and small schools consortium. **\$269,508**
- d. LD Diagnostician/Counseling Contracts for additional services to Adrian, Annex and Nyssa. **\$150,000**
- e. McKinney Vento Homeless Grant to provide support for homeless students within the county. **\$26,000**

#### **2. Technology Support/Instructional Technology/ Drivers Education for Component School Districts**

- a. MyON Reading Program-contracts to districts covering half of the cost the MyON, the other half is in the LSP - **\$4,600.00**
- b. Malheur ESD Technology Desktop Support Program including WAN Services – Individual district contracts with Malheur ESD. Billed to Districts - **\$454,628**

#### **3. School Improvement Services for Component School Districts**

- a. Pre-School Promise – Provides pre-school classrooms ran by ESD Staff, Nyssa and Ontario - **\$563,400**
- b. Eastern Oregon Early Learning Hub – Provide services to increase number of students ready for kindergarten and college or career - **\$338,794**
- c. MIECHV Funding-Maternal Infant Early Childhood Home Visiting support through the early learning hub. This is grant funded. - **\$30,000**
- d. Home Visiting Coordinator-Positions works with the Early Learning Hub in providing home visiting services to families. Grant funded from the FFF- **\$100,000**
- e. Family Support Services. Promote the wellbeing of children and families designed to increase the strength and stability of families. - **\$32,441**
- f. Kindergarten Partnership and Innovation. Develops, implements, and replicates systems of support that strengthen and align early learning opportunities for children and families. - **\$145,181.**
- g. Coordinated Enrollment. Provides coordinated enrollment for early care and education programs. - **\$263,503**
- h. Childcare Resources. Increase the number of early care and education programs, and ensuring they are high quality. - **\$827,352**
- i. STEM HUB-Provides program funding in STEM and Innovative technologies in conjunction with FTE from the LSP- **\$1,002,906**
- j. Carl Perkins Grant-Provides support for M98, Carl Perkins Grant, CTE Revitalization Grants, and Pathways for the 6 county consortium- **\$365,115**
- k. Treasure Valley Tech- Provides welding, CNA, Early Childhood Education, and Automated Control Systems to Component School Districts. Contracts with component districts total \$180,000 and \$60,000 transfer from the LSP, along with beginning fund balance- **\$240,000**

- l. REN Coordinator-Provides backbone structure for teacher/administrator professional development- **\$328,256**
- m. REN Educator Advancement Fund-Provides funding for teacher/administrator professional development- **\$1,047,215**
- n. REN Grow Your Own-Provides funding for recruitment of licensed staff through scholarships in approved programs- **\$609,131**
- o. School Safety and Prevention-Provides suicide prevention, school safety, and threat assessment services- **\$144,015.**
