

English3 International Student Scholarship – Terms & Conditions

Last updated: July 28, 2025

These Terms & Conditions (“Terms”) govern participation in the Homebase Scholarship (the “Scholarship”) organized by **English3 LLC** (“we,” “us,” or “the Organizer”). By applying, you agree to abide by these Terms.

1. Eligibility

- Must be **16 years or older** at the time of entry.
 - Open to applicants **worldwide** planning to study internationally within 24 months.
 - One application per person.
 - Employees, contractors, and affiliates of the Organizer are **not eligible**.

2. Scholarship Award

- One winner will receive a **\$1,000 USD cash prize**.
 - The award is **non-transferable, non-exchangeable**, and has **no cash substitute**.
 - Disbursement will be made via **bank transfer** after verification.

3. Application and Selection

- Applications must be complete and truthful.
- The deadline is **the last day of each month**.

- The winner will be notified via email within **15 days** of the deadline.
 - Selection is based on eligibility, completeness, and merit of application responses, at the Organizer's sole discretion.

4. Verification

To claim the award, the selected winner must:

- Respond to notification within **10 business days**.
- Submit **proof of enrollment** (or application or acceptance) at a post-secondary institution. Name on enrollment/transcript must match the name on entry.
- Provide valid **government-issued ID**.
- Complete required forms (e.g., **W-9** or **W-8BEN**, if applicable).

Failure to comply within **30 days** may result in disqualification and selection of an alternate recipient.

5. Taxes and Financial Responsibility

- All taxes and reporting obligations are the responsibility of the recipient.
 - We do not provide tax advice; consult your local tax advisor.

6. Data Use and Sharing

By applying, you consent to the Organizer:

- Collecting and processing your information in accordance with the [Privacy Policy](#).
- **Sharing your data with vetted partner universities and scholarship sponsors** for outreach, scholarship opportunities, and marketing related to higher education.

- Sending occasional communications, including promotional content related to studying abroad. You may unsubscribe at any time.

7. Use of Winner Information

By accepting the award, the winner agrees that their **first name, country, and a brief quote** may be used by the Organizer for promotional purposes.

If applicable law requires, we will obtain separate written consent.

8. Right to Cancel or Modify

We reserve the right to cancel, suspend, or modify the Scholarship, including these Terms, at our discretion. This may include disqualification of any individual who violates the Terms or attempts to manipulate the process.

9. Limitation of Liability

The Organizer is not liable for any:

- Technical failures or interruptions
 - Lost or misdirected applications
 - Delays in communication or disbursement
 - Any direct or indirect damages arising from the Scholarship

These Terms are governed by the laws of the **State of Utah**, without regard to conflict of law principles.
