A community-wide educational event showcasing a Netflix miniseries and an Ohio Innocence Project case focusing on racial justice, mental health awareness, and suicide prevention.

Presenters:

Kevin Richardson – known from “The Central Park Five” case, story was created into a Netflix miniseries, “When They See Us.” According to The Washington Post, Richardson and four other African American and Hispanic teenagers were wrongfully accused of brutally raping a white jogger in Central Park. Richardson served about seven years in prison before the true assailant, Matias Reyes, confessed to the crime in 2002.

Attorney Pierce Reed – Program Director for Policy, Legislation and Education at Ohio Innocence Project (OIP). OIP has assisted in the release of 30 Ohioans who collectively served 600 years in Ohio prisons. OIP’s mission is to assist in freeing the staggering number of innocent people who remain incarcerated, and to bring reform to the system responsible for their unjust imprisonment.

Laurese Glover – Exoneree through Ohio Innocence Project. Laurese was involved in the “East Cleveland Three” case where he was charged with a 1995 murder, that he did not commit. OIP assisted in Laurese’s release and his case was overturned in 2015.

Judge Carla Baldwin – First African-American female judge in Mahoning County. Judge Baldwin was previously the magistrate at Mahoning County Juvenile Justice Center.

James DeLucia – Clinical Director at Mahoning County Juvenile Justice Center

Carmella Hill – Clinical Director at Coleman Health Services, Trumbull County

Dr. Doug Smith – Psychiatrist from Summit County ADM Board

OIP’s work has led to the release of 33 wrongfully convicted Ohioans, who collectively served nearly 650 years behind bars. OIP’s work includes helping develop and advocate for lasting criminal justice reform through legislation as well as launching Ohio Innocence Project University, an active network of student groups at colleges across the state.
