

The Reading of the Great Karnak Inscription: A New Translation

After interpreting the Great Inscription at Karnak I must conclude that the Egyptologists really cannot read the Hieroglyphics in the way that they claim to be able to.

This is the interpretation of the inscription;

These are the instructions for the people who came here as captives (refugees.) You need to understand that we have strict laws here and they must be obeyed. You need to know you need to be good to live with us in our land.

We are the ones who will tell you what is right and what is wrong. You must treat others as you would want to be treated.

We are the ones who are in communication with the gods and you must obey us to be with us.

You came from other lands and you were not very civilized and you need to be civilized. We are the ones who came here first and we are the ones who built everything you see around you.

We are the ones who know right from wrong and you must obey us as we rule this land. You need to obey all the laws and you must not be violent and kill anyone without just cause as this will be dealt with by the courts.

We are the ones who make the laws and you must obey them or you will be sent away.

We are the ones who rule this land and we are like the gods and you must obey us.

You are the one who came when your lands were destroyed and you were destitute and we allowed you in. (The Sea People.)

We are here because God allows us to be here and you must be the same to stay.

You will be executed if you break the law severely.

You must understand that we are the rulers and we will say what is done.

You are what we call uncivilized people and were very degraded when you came here.

You need to learn to be civilized if you want to stay.

You need to understand you are not like us. We are superior.

You are the ones who became degraded and God left you like that until we helped you.

These are the laws you must live by, or you will be executed, or exiled.

This is a clear reading of the Karnak Inscription. It is obvious from this reading that the Egyptologists fake their interpretations of the hieroglyphics. This practice, it seems, started with Muller (Egyptological Researches, Washington, 1906) who also faked the translations of the Rig Veda.
