- c) Nora In reply to Yuki: The author was not associated, but she does work as an editor. Writing for a university is different from a publication
- d) Dan operations and legal perspective. There's a difference between the Binghamton Review Resolution and this resolution. The Review was in response to an inappropriate joke. With this resolution, we are getting very close to violating the freedom of the press. Pipe Dream is chartered, but they willingly don't accept funding to retain their freedom of the press. They are autonomous to some degree. I believe passing this is a dangerous precedent of freedom of speech and also stepping on the toes of Pipe Dream, who wants to stay separate from us. I don't think this resolution is going to help with what it's intended to do. Best to put it away as a teaching moment and move on- this will just further the division

      - (1) Eli in response: E-board meetings every week will discuss matters by Congress. 6 people on E-Board are all working as a team to respond to requests.
    - c) Jeremy did not need legislation, can just be talked through. And communication would have fixed this.
    - d) Kenzie heard about complaints from Congress, that can be just talked about and communicated. Directly address the person if you have feedback for them.
    - e) Saul Thinks it is important that this is codified so Congress can know and have expectations of future E-Boards
    - f) Nick if you want to reference the SA as a whole, the resolution should be more broad and not just specifically pointing out 3 chairs
      - (1) Saul response resolution specifically addresses the 3 chairs as a request, but can be used as a template for any future chairs
