Terms of Service

Please read the terms of service carefully
by commissioning me, you are accepting these terms.

1.GENERAL TERMS

- Your commission can only be used for personal use, not for commercial use. For commercial use consult me.
- I can reject your commission request for any reason.
- If you constantly harass me and you are rude to ask me if the drawing is finished, I can cancel the commission and will not give a refund.
- You are allowed to publish your commission finished with credit on social media (X (Twitter), Instagram, etc.) Do not forget to put credit. I reserve the right to publish or not the commission on my social networks.
- Do not claim my art as your own.

2.PROCESS & DELIVERY

- I will only make editions to the line art and not after the shadow and coloring unless the edit is important as missing markings, accessory, wrong color, etc.

- I will notify you when we are getting started. Once the commission has been started, you will no longer be permitted a refund.
- Once your commission has started, I will be in contact with you throughout the process of the piece. My job here is to try to make you as satisfied as possible with your commission.
- You will receive from me a: HQ image with my respective signature and logo.
- I can take between 1 week or less, to 5 weeks to complete the drawing.
- Provide a clear reference sheet or pictures, the more detailed you are, the better. For your commission request to be considered, be very clear with what you want.
- I will provide sketches / WIPS when I have them available.
- Please do not constantly ask me to show you a drawing advance. When I can, I will be sending the process of the work (ex: Sketch, Line Art, Coloring, Shading).

3.CUSTOM DESIGNS

- **Reference Materials:** Please provide clear and detailed references for your request (e.g., species, pose, color palette, accessories, expression, background, etc.). Visual reference images are highly encouraged to ensure accuracy.
- **Resale and Gifting:** You are permitted to gift the design or resell it; however, the resale price must not exceed the original purchase price.
- **Revisions:** Minor adjustments may be requested after the design is completed. Extensive changes may incur additional fees.

- **Personal Modifications:** You are welcome to modify the design yourself, provided that credit for the original creation is always attributed to me.
- **Ownership and Copyright:** Under no circumstances should you claim the original design as your own creation. I retain the intellectual property rights over the original artwork.

4.ADOPTS

- **Design Modifications:** You are permitted to make changes to the character's design as long as the original version remains recognizable. Credit for the original design must always be attributed to me.
- **Copyright:** You may not claim the original design as your own creation.
- **Payments:** All character adoptions must be purchased via PayPal invoices/payment forms.
- **Resale Policy:** Adoptables may only be resold for their original purchase value.
- **Redesigns:** If you choose to redesign the character, any subsequent sale must include the original design files.
- **Gifts and Trades:** You are welcome to gift or trade my designs. However, if you acquired a design through a gift or trade, you may only re-gift or trade it again; selling it for currency is prohibited.
- **Delivery:** A Toyhouse account is required for the official transfer of the adoptable.

5.BASES

By purchasing and acquiring these bases, you agree to the following terms:

- **Permitted Usage:** The licensee is authorized to create original designs for personal use, develop "adoptables" for resale, and generate reference sheets for their own characters.
- **Commissions:** You may use these bases to fulfill custom design commissions for third parties.
- **Attribution:** Proper credit is mandatory. You must provide a direct link to my official social media profiles or the original store link whenever the base is used.
- **Watermark Integrity:** The original watermark must remain visible. You are permitted to adjust its size and color, provided it remains legible and recognizable.
- **Modifications:** Users are allowed to modify or add elements to the lineart to suit their creative needs.
- **File Format:** All bases are sold exclusively in .PSD format. No alternative file versions will be provided upon request.
- **Distribution Restrictions:** Redistribution, sub-licensing, or reselling of the raw base files is strictly prohibited.
- **Anti-Tracing Policy:** Unauthorized tracing of these bases is a violation of these terms. Any instances of tracing should be reported immediately; violators will be permanently blacklisted.

6.PAYMENT

- The prices are in USD and payments are taken only through paypal invoice.
- Once the commission is quoted, PayPal fees will be added (5.4 % more \$0.30 USDs) at the full cost of the commission.
- In order to start with your commission I require 100% payment in advance.
- Don't send me any payment before I have agreed to take on your commission request. Thank you!

REVISIONS

- If you wish for me to change something in the drawing you have previously approved, I will charge you a fee to change it. The amount of the extra charge depends on the change you want me to make. Minor changes are allowed with no extra fee.

Major eg: Pose Change, Facial Expression, Hairstyle / Minor eg: Colour change.

7.REFUNDS AND CANCELLATIONS

- The buyer is not allowed a refund once I have started working on the commission. If we stop midway, we can discuss a partial refund depending on where we are at in the artwork stage.
- If you cancel your order before I started it, you will receive a full refund.

IMPORTANT:

- If you request a Paypal chargeback at any point when you were not allowed to ask for a refund you will lose all aforementioned rights to the commissioned piece and I will have the full right to profit further from it in any way. I will decline the chargeback and supply Paypal with our conversations in which we talk about the commission as evidence that I have completed work for you. Furthermore, you will be blacklisted from commissioning me again.

8.WHAT I DO/ DON'T DRAW

- **DO:** Any kind of species or Human - Oc's - Fanart - NSFW - Candy Gore - Light Gore
- **DON'T:** fetishes, abuses, homophobic, transphobic, racist or any kind of hate - excessive gore - Mechas - NFTs
