Treasurer's Annual Report – Steve Kinney

- On December 31, 2019 the PSOA bank account balance was \$17,481. On December 31, 2020 the PSOA bank account balance was \$15,261. On December 31, 2021 the PSOA bank account balance was \$22,188.84. On January 19, 2022 the PSOA bank account balance is \$15,353.84. There are 4 checks for 2020 (\$251), 26 checks for 2021 (\$7,402) and 3 checks for 2022 (\$401) that have not cleared the account.
- Due to the pandemic, an audit on the PSOA files was not done in 2021.
- Commonwealth of Virginia State Corporation Commission: Annual registration fee of \$25 was paid on November 30, 2021.
- The 2022 P. O. Box annual fee of \$182 was paid on January 18, 2022. The rate increased \$64 from last year.
- The ArbiterSports license is renewed annually and \$2,104 was paid on September 22, 2021. We also added one more sub-admin account for \$40.
- PSOA Liability Insurance with K&K Insurance Group, Inc. is renewed annually and \$1,459 was paid on September 11, 2021. The contract expires on September 21, 2022.
- The Microsoft Office 365 license is renewed annually and \$69 was paid on December 3, 2021. The current license expires December 2, 2022.
- PSOA donated \$500 to the Lab Rescue in honor of Jeff Lord and donated \$100 to Mike Schatzel's family due to losing everything in a house fire.

Year in Review - Mark Rader

2021 was another challenging year for PSOA and its members. Coming off the year of Covid in 2020, we resumed soccer to a level of approximately 60-70%. At least things started to get back to normal. What wasn't normal was our number of available referees, which went from 400 to 200.

- January 2021 26 attendees via Zoom. Held annual elections via Zoom and by no opposition to EC positions, the new EC was established with the team that stepped up. Long-time President Ross Small handed down the gavel to Mark Rader.
- February 2021 50 attendees via Zoom. High school started an early season in February for private school boys to make up for the lost Fall 2020 season. Training topic was "Handling", which has become the most confusing Law on the books.
- March 2021 53 attendees via Zoom. Travel leagues started up. Public high school delays season until May & June, extending beyond the last day of school. Private school girls played April & May.
- April 2021 31 attendees via Zoom. 4 new members online. 18 mentors identified. Training on FRD, drop balls, build-out lines.
- May 2021 19 attendees via Zoom. Bylaw updates continue peer reviews being conducted.
- June 2021 12 attendees via Zoom. Bylaws in final review. Picnic will take place in August. Jack Zamora retiring and also stepping down from IOW assigning.
- July 2021 No meeting.
- August 2021 Meeting was the picnic at Bethel Park. Approximately 55 attendees plus some extras
 who were attending the wrong picnic at first we had plenty of food and directed them to the
 correct venue. Gave out dry bags. We have plenty if you need to purchase for \$10.
- September 2021 12 attendees via Zoom. Jeff Lord passed away. Fall leagues started. Presented new
 contract presentation for high school to Bay Rivers District. Lost contract to TSRA after 25 years. We
 will battle back on this.
- October 2021 24 attendees via Zoom. Heldur Liivak initiated a memorial for Jeff Lord at Wolftrap Park. Referee Academy held in VA Beach. Lifetime members were added – Heldur Liivak, Don Reese, Ross Small, Antonio Araiza and Jeff Lord.
- November 2021 21 attendees via Zoom. 2 referee training sessions held. Elections discussed. New assigners appointed.
- December 2021 28 members and family attended the pizza party held at 1700 Brewing. John Griggs is the owner and manager. Roger Malloy award presented to Ross Small. Antonio Araiza passed away on December 28.

 - o 2021 was a year we got back to a limited number of games due to the COVID-19 pandemic.
 - o Leagues played a reduced number of games. There were 1,037 games played.
 - o Approximately \$45,758 was paid out to referees.
- Mark Rader High School Matches (Public/Private)
 - o 2021 was not entirely back to normal due to the continued uncertainty of the COVID-19 pandemic.
 - o There was an early, reduced Private School Boys Spring Season (February 5 March 31, make-up from lost Fall 2020 season), a reduced Private School Girls Spring Season (April 1 May 1), a reduced Public School Boys & Girls Spring Season (April 25 June 23, extending beyond the graduation date), and a Private School Boys Fall Season.
 - o Approximately \$93,537 was paid out in HS referee fees.
 - o The Bay Rivers District contract was up for bid in September, and even though PSOA had held that contract for over 25 years, they awarded it to TSRA. We will follow this closely and be ready to compete for the contract again in 2023.
 - o Beginning January 1, 2022, Steve Kinney will take over the responsibility as the High School Assigner. After 22 years, I have decided this is a good transition year for this. I took pride in ensuring that the schools had referees at every scheduled game. It has been an honor and a pleasure to perform this duty in support of high school soccer.
