

- Legislative updates as pertains to CTE
 - o HF2465 Science/Ag Credit
 - Technical assistance sheet coming soon
 - CTE educators are not required to hold science or math endorsements.
 - Alternate certified CTE teachers may only teach in the area for which they are certified.
 - Example Ag Teacher only certified to teach Animal Science may only teach an Animal Science class for science credit.
 - Can be coded retroactive September 2024
 - Up to 2 science credits can be met by using a similar ag class
 - Recommended SCHED codes
 - o 18051 Plant Systems/Science
 - o 18105 Veterinary Science
 - o 18101- Animal Production/Science
 - o 18504 Natural Resources Management
 - Up to 2 math credits can be met by using similar applied sciences class
 - Recommended SCHED codes
 - o 17002 Construction Comprehensive
 - o 13002 Manufacturing Comprehensive
 - o 17006 Woodworking
 - o 13207 Welding
 - o 20104 Automotive Comprehensive
 - o 21102 Drafting General
 - Work Based Learning Changes SF2411 Definition: "work-based learning " means opportunities and experiences that include but are not limited to sustained project-based learning in partnership with an employer, simulated work experiences aligned with industry-recognized credentials, high-quality pre-apprenticeships aligned to an apprenticeship, student learner programs, internships, and apprenticeships.
 - Beginning with the 2024-2025 academic year, only those activities noted in the new definition of "work-based learning" will count toward:
 - Every Student Succeeds Act (ESSA) school accountability work-based learning measure; Perkins Secondary Career and Technical Education 5S3 work-based learning measure; and Iowa Student Outcomes work-based learning interactive dashboard.
 - Schools will leverage existing SCED codes and new embedded work-based learning codes to report these activities to the Iowa Department of Education.
