Book reviews should be about 800 words in length and include the reviewed work's author, title, date of publication, publisher, with a heading including the number of pages, cost, and ISBN. The reviewer's name and institution will appear at the conclusion of the review upon publication. The book review should be uploaded by the reviewer within three to six months of receipt of the book. We are obligated to send a copy of a published review to any publisher who provides a free review copy to the journal.
