Middle of the Year Reading Goal	By February 2023, 35% of students in Kindergarten through 8th Grades will be proficient in Reading, as measured by the NWEA MAP assessment.
End of the Year Reading Goal	By June 2023, 50 % of students in Kindergarten through 8th Grades will be proficient in Reading, as measured by the NWEA MAP assessment.
Middle of the Year Mathematics Goal	By February 2023, 30% of students in Kindergarten through 8th Grades will be proficient in Math, as measured by the NWEA MAP assessment.
End of the Year Mathematics Goal	By June 2023, 45 % of students in Kindergarten through 8th Grades will be proficient in Math, as measured by the NWEA MAP assessment.

STUDENT GROWTH GOAL

The **median growth percentiles** in grades K to 8 on reading and math will be **at or greater than 50** as measured by NWEA MAP.
