

Tez App Privacy Policy

Introduction

This Privacy Policy describes how Tez app ("we", "us", or "our") collects, uses, and shares information through our mobile application ("App"). We are committed to protecting your privacy and ensuring you understand how your information is handled.

Information We Collect

We collect the following types of information:

Information You Provide

- **Account Information:** When you register, we collect your username and email address.

Information Collected Automatically

- **Device Information:** We collect information about your device type, operating system version, and device identifier. This information helps us optimize the App for your specific device.
- **Usage Information:** We collect data about how you use the App, including session duration and feature usage. This helps us improve the App's functionality.
- **Error Reports:** We collect error reports to identify and fix technical issues.

How We Use Your Information

We use your information for the following purposes:

- To provide and maintain our services
- To notify you about changes to our App
- To allow you to participate in interactive features when you choose to do so
- To provide customer support
- To gather analysis or valuable information so that we can improve our App
- To detect, prevent and address technical issues

Data Storage and Security

- All user data is stored on secure, encrypted servers
- We implement appropriate technical and organizational measures to protect your personal data

- We retain personal information only for as long as necessary to provide the service you have requested
- In the event of a data breach, we will notify affected users in accordance with applicable law

We Do Not Track Users

Important: Our app does NOT track users across apps and websites owned by other companies, and we do NOT share your data with data brokers or third-party advertisers. We do not:

- Use your data for targeted advertising purposes
- Share your data with third-party advertising networks
- Combine your data with other datasets for advertising purposes

Third-Party Services

The App may use limited third-party services for app functionality and analytics:

- **Apple Analytics:** We use Apple's built-in analytics to understand app performance
- These services collect anonymous, aggregate information that cannot be used to identify individual users

Your Rights and Choices

You maintain control over your information:

- **Access:** You can request a copy of the information we have about you
- **Correction:** You can request correction of inaccurate information
- **Deletion:** You can request deletion of your account and associated information
- **Restrict Processing:** You can request we limit how we use your information
- **Data Portability:** You can request to receive your data in a structured, commonly used format

App Permissions

The App may request certain permissions on your device:

- You can manage these permissions through your device settings
- You may revoke permissions at any time, though this may limit some App functionality

Children's Privacy
