GENERAL INFORMATION

- **Vendors must supply all of their own materials and equipment**
This includes tents, tables, chairs, etc.
- **Electricity is not available**
Only food vendors may request power access or coordinate the use of a generator
- **Water access is limited**
Vendors should plan to supply their own water since it may not be available everywhere
- **Vendors must dispose of their waste**
On-site trash, recycling, and compost facilities will be available
- **Tents must be secured with weights**
Securing tents with stakes is not permitted



ARRIVAL INFORMATION

Once you arrive at your assigned block, please look for your Booth Space Number marked in chalk on the pavement/curb

- EVEN NUMBERS are on the EAST SIDE of the street
- ODD NUMBERS are on the WEST SIDE of the street

If you need help finding your space, a Block Captain wearing a badge + vest can assist you, or you may call or text the Vendor Support Line. Do not take a space just because it looks empty- you will be redirected to your assigned space.

Pull up to your space, unload, and move car off route as quickly as possible

- Do not park in the middle of the street when loading in/ loading out
Two full access lanes must be maintained
- After unloading, vendors must park vehicles outside of the event area
- There is no designated vendor parking

We advise that you find space on a side street as close to Mississippi Ave as possible

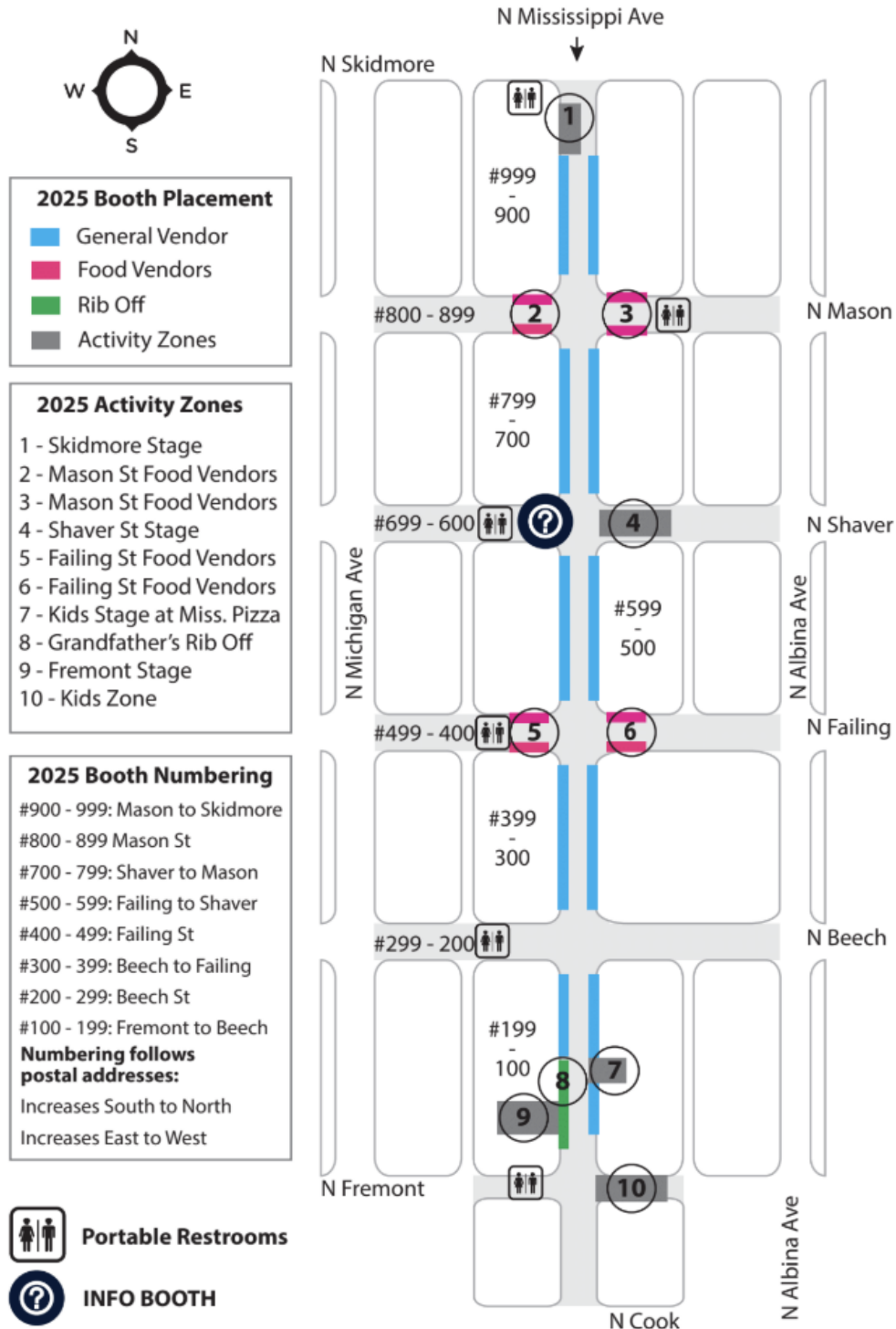

General Fair Map

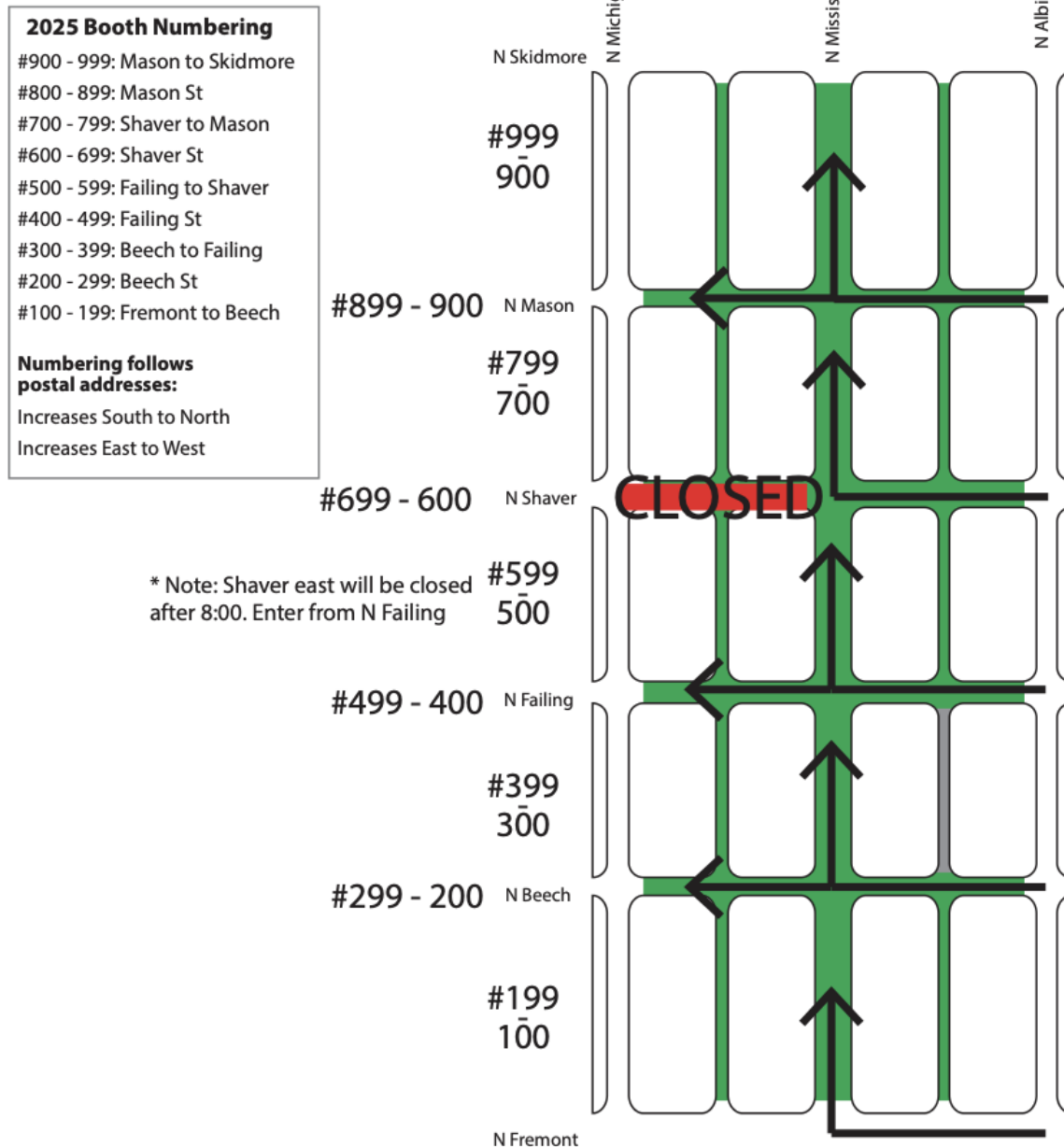

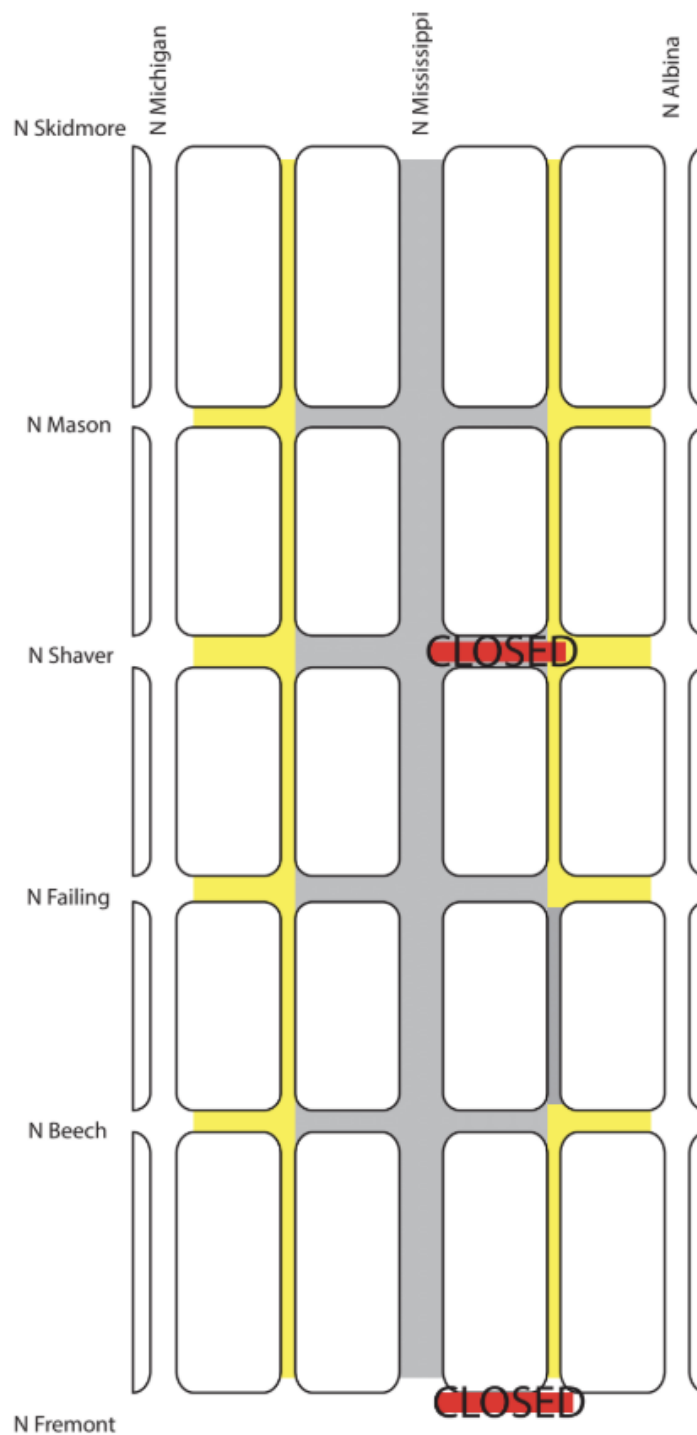

FOOD VENDORS

- **MUST have a copy of their temporary restaurant license**
Stringent health inspections will occur. Contact the Multnomah County Health Department <https://multco.us/services/temporary-food-events> or call 503-988-3400 for more information. Applications must be submitted to Multnomah County at least two weeks prior to the event.
- If using propane, food vendors need to obtain a permit from Portland Fire & Rescue. Visit www.portlandoregon.gov/fire/76752 or call 503-823-3712.
- **If food vendors sell out during the event, they will not be able to leave before 6pm**
