## PERSUASIVE SPEAKING

Contestants will prepare an original persuasive speech on a proposition of fact, value, or policy. The speech will seek either passive agreement or immediate action from the audience. Topics should be relevant to today's society. Speeches should include the use of emotion, logic, and credibility and should be organized with an acceptable persuasive strategy. Speeches must include at least three complete citations of research. Careful attention should be given to language usage, creativity, organization, and effective delivery. Contestants are required to include PowerPoint slide(s). A maximum of three notecards or a one-page outline may be used.
