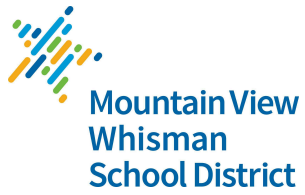

|              | The ELAC has advised the School Site Council on the development of the Single School Plan for Student Achievement. (EC 64001[a])  |
|              | The ELAC has advised the principal and staff on the school's program for English learners. (EC 52176[c], 62002.5)   |
|              | The ELAC has assisted in the development of the school's: <i>1) Needs Assessment,</i>   |
