Introductions

Budget Update

- Report on email vote - all 4 requests passed (second grade zoo trip, STEAM Career Day breakfast for volunteers, snacks for Art Gallery Walk, and food for STEAM night (dinner followed by presentation) . Request for money for Art Gallery Walk was withdrawn.
- Further, the email vote approved a budget amendment: funding request line item increased from \$1000 to \$2500. Thanks to all who voted. Goal is to always hold votes at meetings. Will streamline funding request process and timeline to make that possible.
- Voting on new funding requests - \$500 for 8th grade fees for students who need assistance, \$300 additional field day funding, \$50 in recess supplies for Ms. Surdej's class, and \$25 for decks of Uno cards requested by 3rd grade students. These requests were all unanimously approved at the meeting.
- Committee Updates
 - Fundraising:
 - Results of Great Give - \$2028 from 45 donors: thanks to all who contributed and urged friends and family to do so
 - \$1500 donation from neighborhood letter
 - Brings fundraising total for the year to over \$13,000

- Playground: we are still waiting to hear from the BOE about possible improvements to our playground
- Principal's Update- provided by Assistant Principal Andrea Rizzo
 - Field day will be on June 13. Parent volunteers and donations of water are requested.
 - Principal Smith is working with SPMT to get a draft parent handbook together. She and Holly J. will meet next week to work on draft to present to the rest of SPMT.
