Principles

As a pre-college summer program of the School of Theology and the College of Arts and Sciences at The University of the South, SUMMA Theological Summer Camp seeks to cultivate and maintain an inclusive scholarly community in all which share together in the enterprises of learning and worship. The guiding principles we aim to emulate at camp include:

- 1. Respect for University personnel, facilities, and resources on the domain.
- 2. Embodiment of "faith seeking understanding" in research, writing, speaking, and listening;
- 3. Honor of the dignity, ideas, rights, and personhood of each program participant;
- 4. Communication with one another in the spirit of "speaking truth in love."

A. Code of Conduct

As an institution affiliated with the Episcopal Church, the University of the South has <u>certain</u> <u>standards</u> of conduct that apply to all students. As pre-college guests of the University, campers are expected to follow the University standards of conduct, as well as rules that pertain specifically to participants in SUMMA. Among these are the values articulated in the University's motto *Ecce Quam Bonum* "EQB": "Behold how good and pleasant it is when kindred live together in unity" (Psalm 133:1). The five pillars of EQB are: living with personal integrity, respecting the dignity of all, valuing freedom of thought and expression, demonstrating self-control, and developing trusting relationships. This code of conduct applies to camp participants beginning on the SUMMA start date or the camper's arrival to campus—whichever comes first—and concludes with the end of the program and the camper's departure. Participating in SUMMA means that a camper will:

- **A.1.** Act as a good citizen by showing respect and courtesy to all members of the University community, including fellow participants, staff, seminar leaders, speakers, clergy, instructors, campus neighbors, and affiliates.
- **A.2.** Recognize that SUMMA is, by definition and character, a "theological debate camp." This means that our program-resolutions, lectures, seminars, readings, and debates-will focus on theological topics and controversies within the rich and inclusive context of the University of the South's Episcopal identity. As stated in its 2024-2030 Strategic Plan, the University seeks "to reinforce the value of our Episcopal heritage and identity that is open, generous, and thoughtful; invested in supporting communities of spiritual practice; works to advance diversity, equity and inclusion; and strives to be a force for global justice." Year after year, campers tell us that SUMMA marked a pivotal point in their lives by sparking their intellectual curiosity, preparing them for college, cultivating an appreciation for the art of rhetoric, and strengthening their appreciation for Christian faith traditions. While SUMMA participants need not be Episcopalian or identify as Christian to have a meaningful time, the program will investigate its subject matter from a Christian theological standpoint. This means that participants engaging in theological debate at SUMMA agree to research, appraise, and draw upon various sources of knowledge-both sacred and secular-to craft original, clear, and compelling arguments. The decision of how (and how best) to do so remains entirely within the purview of the participants; staff are here to guide and support them in that process.
- **A.3.** Contribute to a safe and healthy community environment by using methods of expression that

are appropriate to a healthy living-learning environment. Obscene, vulgar, derogatory, demeaning, untruthful, and/or abusive language is strictly prohibited, as it violates University policy and directly contradicts our motto of "speaking truth in love."

- **A.4.** Respect University, program, and other community members' property and material, including equipment, furnishings, and facilities. Equipment includes (but is not limited to) books, laptops, communal computers, tables, chairs, games, and other program materials. Property and facilities include (but are not limited to) residence halls, classrooms, athletic facilities, dining halls, libraries, practice rooms, worship spaces, and indoor/outdoor common areas. Vandalism, malicious destruction, damage, or misuse of private or public property while in the program may result in immediate dismissal. Campers agree to not commit, or threaten to commit, acts of violence such as vandalism, malicious destruction, damage, or misuse of private or public property.
- **A.5.** Abide by the University Non-Retaliation, Anti-Harassment, and Retaliation Policy, which prohibits any form of discrimination or harassment based on race, color, sex, religion, national origin, age, disability, sexual orientation, gender identity, veteran status, pregnancy and childbirth, and genetic information. Harassment of all types, including sexual harassment, by any member (faculty, staff, students, applicants) of the University community is a violation of Federal and State laws and University policy and will result in dismissal from the program.
- **A.6.** Abide by the <u>University Title IX and Sex Discrimination Policy</u>, which prohibits discrimination and crimes of discrimination on the basis of sex in any federally funded program or activity. This policy extends to sexual harassment and assault.
- **A.7.** Behave in ways that do not expose oneself or other program participants to injury or endangerment, regardless of intent.
- **A.8.** Not assist or attempt to assist others in suspected or known violations of the Code of Conduct and any other University policy, procedure, rule, or code. This includes knowingly concealing information about a suspected or known violation from program staff.

All camp staff are empowered to enforce the standards of expected behavior and the Program Director has the authority to send a student home for serious, flagrant, and/or repeated violations of these standards. No camp fees are refunded for program participants who are sent home.

C. General Housing and Living Policies

All campers, counselors, and staff in the SUMMA program will stay in <u>Quintard Hall</u> on the University of the South campus. Quintard's first floor has a large kitchen with dining room, a study room, a parlor with fireplace, a laundry room, an exercise/TV room, and an indoor bicycle room. There are large TV lounges located at both ends of the second floor. Quintard also contains an elevator. Quintard Hall is air-conditioned. It also has a back patio with a grill. Adult staff members are housed on each floor to guide and help campers. Campers are not permitted inside a dorm room other than the one they have been assigned.

B.1. Students are expected to respect others in the program, as well as all University citizens, community members, and neighbors, while enrolled and on campus. Violence, threats of violence, intimidation, bullying, bribery, stalking, belligerence, and menacing behavior are prohibited.

- **B.2.** Students are expected to respect University officials, program directors, and program staff while participating in the program. Failure to identify one's self, evasion of University officials, failure to comply with a reasonable request, failure to respond to questions, harassment, or belittling of staff performing their duties and disrupting program or University operations or authorized non-University activities while on campus is prohibited and may result in dismissal from the program.
- **B.3.** Students will receive a room key and ID card upon check-in at the University. The ID card will be the access card for meals in McClurg Dining Hall, exterior entry to the residence hall, and the fitness center. The key will also be for the dorm room. Students should carry the ID and key at all times. Students should lock their door at all times, and should not share their room key with anyone else. The University is not responsible for lost or stolen property. There is a \$50 charge to replace an ID and \$75 to replace a key. This is charged to the student.
- **B.4.** Students are required to sleep in their assigned rooms and may not change rooms or sleep in another student's room at any time and for any reason. Students may not change rooms without permission from the Program Director or Camp Director.
- **B.5.** Each student must personally maintain their assigned room. The room must be cleared of all personal belongings before departure.
- **B.6.** A curfew has been established both for the safety of the campers and to make sure everyone is well rested to enjoy daily activities. Students will check in with an assigned staff member by 10:15 p.m. in person each evening to verify that they are in the residence hall building and observe lights out by 10:30 p.m. Students are expected to stay in their room for the duration of the night, with the exception of an emergency situation.
- **B.7.** Students residing in campus residence halls during the program may not use, possess, distribute, and/or conceal any of the following:
 - Weapons, as defined by University policy, refer to any device, instrument, or substance that is designed to, or reasonably could be expected to, inflict a wound, incapacitate, or cause serious bodily injury or death, including, but not limited to, firearms (loaded and unloaded, real and replica), ammunition, electronic control devices (such as tasers and stun guns), devices designed to discharge an object (such as bb guns, air guns, pellet guns, potato guns, and slingshots), explosives, dangerous chemicals (such as tear gas) or chemicals designed to incapacitate, martial arts weapons, bows and arrows (longbows, recurves, compound and crossbows), artificial knuckles, nightsticks, blackjacks, dirks, daggers, swords, and knives with fixed blades longer than four (4) inches. Objects that, while not designed as a weapon, but are in the moment used as one (e.g., a student who strikes another with a baseball bat), will be considered a weapon under this policy. Excepted from this definition of "weapon" is chemical repellents available over-the-counter for self-defense and used solely as self-defense, or instruments used solely for personal hygiene;
 - Explosives, including firecrackers;
 - Launchers of any kind, including water launchers, t-shirt launchers, and potato launchers;
 - Alcohol:
 - Tobacco products, including cigarettes and vapes;

- Illegal drugs, <u>according to University policy</u>, are prohibited and include marijuana, narcotics, hallucinogens, and/or other dangerous drugs;
- Drug paraphernalia such as smoking devices, bongs, roach clips, miniature spoons, homemade bongs, scales, cigarette papers, needles, and various types of pipes;
- Hoverboards, skateboards, and scooters;
- Darts and dartboards;
- Nails, screws, tacks, or other devices that insert into the walls;
- Animals and pets (including mammals, birds, amphibians, reptiles, and spiders);
- Items that require an open flame to operate (such as lighted candles, incense, Bunsen burners, or alcohol burners) or which produce heat (such as hot plates, popcorn poppers, space heaters, or heating pads);
- Any other flammable or combustible items.
- **B.8.** Objects may not be thrown out of windows and screens may not be removed.
- **B.9.** In residential hall kitchen and dining areas, students should use these spaces in line with their purpose. Students are expected to clean up after themselves, be mindful of food allergies of other students, and respect the food and belongings of other students and staff. Students should not transport any dishware from McClurg Dining Hall into the residential hall and should not transport kitchen appliances into dorm rooms.
- **B.10.** Students are expected to use only the University facilities appropriate for participation in camp. Off-limits to campers include: (a) residences of any person, affiliated with the SUMMA program or not, (b) residence halls other than the one assigned, and (c) classrooms or other facilities used by other programs on campus. The roofs, ledges, balconies, basements, attics, unassigned rooms, and/or mechanical/electrical equipment rooms of all University-owned buildings are strictly off-limits to students.
- **B.11.** Students must comply with fire safety regulations posted in buildings while on campus. Students must immediately evacuate buildings when a fire alarm sounds. Tampering with fire equipment, including extinguishers, fire sprinklers, smoke alarms, smoke detectors, connecting signs, exit signs, and alarm boxes is strictly prohibited. Students may not prop open or otherwise tamper with a locked exterior door or fire door. Students will be charged a fine of \$200.00 if the fire department responds to a call due to misbehavior and may be dismissed from the program.
- **B.12.** The University of the South is generally a safe community with many well-lighted routes. For their own safety, however, students should walk in groups of two or more any time they are outside. In any emergency situation, campers should notify a camp staff member or Campus Security at 931.598.1111. The Sewanee Police Department operates on a 24-hour per day basis. A police dispatcher is always available to take information or file reports. Campers with electronic devices are encouraged to download a mobile-safety app called LiveSafe. The app empowers students, University employees, and campus visitors to take charge of their own safety and to look out for those around them. There are towers with blue light emergency telephones (or call boxes) that are located at various sites on the campus. In response to a call from an emergency blue-light telephone, police officers are immediately dispatched to the location of the call or complaint. In the dorms, campers should report at once any unknown or suspicious individuals, or other problems, to a camp staff member.

- **B.13.** Students are not permitted to use a car during SUMMA camp. There will be no need for an automobile because all activities on campus are within walking distance of the dormitory and transportation will be provided for any off-site activities. If a camper has a physical disability that prevents them from walking, a staff member will provide transportation on campus. If a camper drives to Sewanee from their home, that camper will be required to leave the vehicle keys with the Camp Director until check-out.
- **B.14.** Students may not ride with anyone, except in transportation provided by trained and certified camp staff, unless arrangements have been made between parent/guardian and the Program Director or Camp Director in advance.

C. General Learning Policies

- **C.1.** Students are expected to attend all lectures, seminars, classes, tournaments, meals, worship services, and other planned activities unless they are ill. All absences will be monitored and reported to the Camp Director. Flagrant and repeated unauthorized absences will result in dismissal from the program, and parents/guardians will be required to pick up the camper early and at their own expense.
- **C.2.** Students will not be excused from events in the camp program without permission from the Camp Director and for sanctioned reasons only (i.e., illness, injury, or disability-related reason). In the event of an emergency, campers will be released with the authorization of the Camp Director. The parent or guardian must contact the Program Director to authorize release of the student, to arrange pick-up times, and to identify who will pick up the student.
- **C.3.** Students should be truthful in personal engagements and uphold high standards of academic integrity, including producing work that is your own creation and meeting intellectual challenges through honest effort and hard work. SUMMA expects you to produce and express original arguments without the assistance of artificial intelligence, unless otherwise indicated in program materials. Be sure to make ample use of program resources and personnel; ask for help early and often.
- **C.4.** Students should always respect academic freedom and others' freedom of expression and inquiry. Theological debate necessarily implies clashing ideas, and we embrace that clash as part of our inquiry together.

D. Visitation Policy

Because we have a full schedule of instructional and recreational activities, parents, friends, and other visitors will not be permitted in lectures, seminars, in the residence hall, or on any trips or other activities of the program without permission of SUMMA's Program Director, Associate Director, or Camp Director. It is especially important that parents, friends, and visitors respect and abide by the visitation policy, since this is a program with members who are pre-college minors. Honoring the visitation policy is especially important when it comes to the residence hall. Should your child forget something and you are local to the area, please feel free to contact the Program Director or Camp Director to arrange for a drop off that does not interfere with camp programming or violate the spaces where minor students will be residing for the program.

Family, friends, and other guests are <u>very</u> welcome to attend selected rounds of the tournament the afternoon of July 21 and morning of July 22, and our closing worship and presentation of awards on July 22. Please let us know if you plan to attend via email at summa.sewanee.edu. Please note that we are unable to provide housing for visitors during camp.

- **D.1.** Students may not have guests or visitors sleep in their rooms during the program. This includes parents, guardians, and/or other family members.
- **D.2.** Students should immediately report any unauthorized persons in the residence halls to the Camp Director and Program Director.
- **D.3.** Parents are welcome to help students move in and out of the dormitory at the beginning and end of the program (i.e., the afternoon of July 15 and the morning of July 23. During the program, however, parents should not be in dormitories without a staff member present. Parents should not request campers provide them with dormitory keys, and should not enter the dormitory, or attempt to enter the dormitory, unannounced at any point.

E. Electronic Devices and Communication Standards

- **E.1.** Cell phones, cameras, iPods, smart watches, laptops, and tablets are allowed in the program. Students should maintain possession of their devices or safely store them during the program.
- **E.2.** Students may not use cell phones during seminars, lectures, classes, debate sessions, or worship for any purpose, including note-taking, calling, or texting. To help facilitate this policy, campers' cell phones will be deposited in boxes immediately prior to lectures and seminar sessions and during their debate time in the tournament. They will be returned immediately afterward. Note that cellular coverage can be spotty on campus, especially in the buildings.
- **E.3.** If a camper is misusing a personal cell phone or other personal electronic device during the program, the Camp Director reserves the right to decide, in consultation with the Program Director and the camper's parents/guardians, if the device needs to be safely stored for extended periods, including overnight. Examples might include taking pictures of other program participants without their permission, sharing inappropriate and/or illegal materials with other program participants, engaging in harassing or bullying behavior, or staying up late and waking up unrested for program learning and activities. Depending on the severity of the infraction, the camper may receive a warning from the Camp Director before the Program Director and/or parents/guardians are involved. In cases of recurring and flagrant violations, a camper will be sent home. In this case, parents assume full responsibility for making any travel arrangements necessary, including the costs incurred for doing so.
- **E.4.** Personal laptops are <u>strongly encouraged</u> for debate preparation, and students will have full access to on-campus computers and printing for the duration of camp. The entire University of the South campus has wireless internet connection. Campers and their families may log on to "Sewanee Guest" to access the internet while here.
- **E.5.** Students should avoid the following infractions when using devices, personal or public: sending communications that constitute bullying; harassment based on gender, race, sexuality,

political affiliation, religious beliefs, and more; harassment of a sexual nature to another program participant, staff member, and/or member of the Sewanee community; and using a device to take photographs without permission or consent of those involved. Serious, flagrant, and/or repeated infractions may result in a) a staff member confiscating the device and returning it at the end of the day; b) a staff member confiscating the device and returning it at the end of the program, in which case parents will be contacted and given an alternate phone number for communication; or c) dismissal from the program.

- **E.6.** During the program, students should treat any communication with other program participants and staff via electronic device during the program in the spirit of SUMMA, "speaking truth in love."
- **E.7.** Students are responsible for their own property. The University of the South and SUMMA will not assume any responsibility for damage and/or loss of any student's devices or equipment.

F. Health Resources and Medications

SUMMA camp staff has at its full disposal the nearby <u>Sewanee Pediatrics</u> and <u>Sewanee Emergency</u> <u>Room</u> in case of injury or a medical emergency. Information about special medical needs must be provided on the camp medical form, as well as a copy of the camper's current insurance card.

- **F.1.** Camper's medications and dosage (including frequency) must be reported on all camp medical forms. If a camper has parental permission to keep in his/her possession and take at his/her discretion any over-the-counter or prescription medications, that must be documented and submitted on the camp Medication Authorization Form before the program begins.
- **F.2.** Students may use over-the-counter or their own prescribed medication in line with the appropriate/assigned dosage. Students may not share their prescribed medication with other students or use the prescribed medication of other students.
- **F.3.** The program continues to follow current University policy related to COVID-19, which can be accessed <u>here</u>.

G. Disciplinary Procedures

We are expecting SUMMA campers and staff to be very conscientious and display the highest and most commendable standards of conduct. For the sake of every person's welfare, security, and safety, camp staff will promptly report to the Camp Director and Program Director any serious, flagrant, and/or repeated violations of the standards of conduct, or of rules and regulations.

The Camp Director will sensitively and responsibly impose the following fair remedies on any campers who clearly disregard standards, or rules and regulations. Other staff members, including the Program Director, may be consulted at the Camp Director's discretion.

1. In the case of use and/or possession of alcohol, illegal drugs, or weapons, or in the instance of sexual harassment, as outlined in the University of the South standards, the camper will be dismissed immediately, and the Camp Director will make arrangements with the

- camper's parent/guardian to ensure a safe return to the camper's home.
- 2. At the first willful violation of any other standard or regulation, the camper's counselor, or another adult staff member, will speak with the camper to remedy the situation.
- 3. At the second willful violation, the Camp Director (and as needed, the Program Director) will speak with the camper and they will not be allowed to participate in the next scheduled (either that day or the next) free time activities.
- 4. At the third willful violation, the Camp Director will discuss the situation with the camper and the camper's parent/guardian. Depending on the gravity of the violation, the camper may be dismissed. In this case, the Camp Director will make arrangements with the camper's parent/guardian to ensure a safe return to the camper's home. Any costs for an early dismissal are incurred by the camper's parents/guardians.

H. Contacting a Camper in Case of an Emergency

Camp staff monitor our email account (<u>summa@sewanee.edu</u>) for the duration of camp, and this is typically the most expedient and appropriate method of communication. In any emergency situation, contact Program Director Melody Lehn at 864.561.9736, or Camp Director The Rev. Gina Brewster-Jenkins at 912.484.4844.

I. What To Bring

Camp fees cover all expenses for room and board, meals, recreation fees, materials, and local transportation. Campers may bring a modest amount of spending money if they wish to make purchases at the University of the South bookstore or the campus coffee shop.

Clothing

In July, the high temperatures will be in the 80s and 90s. Dress for the program's lectures, classes, and field trips is casual. Shorts are acceptable for most activities. Professional dress (e.g., slacks, coat and tie, suit, dress, skirt, or blouse) is expected for debate tournaments. Faculty, staff, and students of the University of the South who judge will typically be "gowned" for tournaments.

The campus athletic center will be available for our use—campers may wish to bring appropriate athletic clothing including swimwear and a towel. Note that swimming at the athletic center is allowed only when a licensed lifeguard is present, which is not during all hours the center is open. Hiking on the campus trails will be offered as an optional recreational activity; campers who plan to hike or explore the Domain may wish to bring sturdy shoes.

Most buildings are air-conditioned and mornings are often cool, so you may want to bring a light sweater or sweatshirt. A hooded rain jacket or poncho, and/or umbrella is also recommended.

Linens

Students are responsible for bringing their own linens: sheets for a long twin bed, pillow and pillow case, blanket (or sleeping bag), bath towels, hand towels, and washcloths. Students may also wish to bring a mattress pad (most mattresses are vinyl and it can be cold at night).

Laundry

Laundry facilities are located in the residence hall. There is no charge for use of the washers and

dryers; however, campers should bring laundry detergent, fabric softener, dryer sheets, etc., if they plan to do laundry.

Meals

Meals are provided, beginning with dinner on Tuesday, July 15, and concluding with breakfast on Wednesday, July 23. McClurg Dining Hall offers a variety of foods to accommodate special dietary needs. Please make note of such needs on the camp medical form so we can make additional arrangements if necessary.

Talent Show

A talent show will be held as one of our evening activities—campers are encouraged, but not required to perform. All campers and staff will attend.

"Talent" is defined broadly and meant to be interpreted creatively. Musical performances, skits, dramatic or humorous readings, dance and gymnastics routines, lip-sync, martial arts demonstrations (without weapons), magic tricks, comedy routines, and juggling are only a few ideas of suitable acts. Appropriate language and content are expected.

Each act/performance is limited to three minutes, and individuals are limited to participation in two acts (unless providing musical accompaniment or singing backup in another act/performance).

Campers may bring props, musical instruments, or other items needed for the talent show. Campers are responsible for their own property. The University of the South and SUMMA assume no liability for lost, stolen, or damaged items.

J. University Facilities

Hamilton Hall

Hamilton Hall, which re-opened for operations, classes, worship, and events in Advent 2024, will host much of SUMMA Camp. Constructed in 1968, Hamilton Hall was first designed as a space for soldiers, not seminarians—it housed the Sewanee Military Academy for over a decade. With the completion of top-to-bottom renovations, Hamilton Hall now fully inhabits the role it took on more than thirty years ago: a hub for world-class theological instruction, Episcopal community-building, and spiritual growth. Plenary lectures, seminars, small-group work, debate preparation, and debates will take place in Hamilton Hall.

Quintard Hall

As noted, all campers will stay in <u>Quintard Hall</u>, which is accessibly located adjacent to Hamilton Hall.

Jessie Ball duPont Library

SUMMA has full access to the Jessie Ball duPont Library during camp. This beautiful building was constructed in 1965 and houses the fully integrated collections for the University's College of Arts and Sciences and the School of Theology. The combined collections include more than 784,000 print volumes and 133,000 media titles. The library also provides access to over 622,000 electronic books or texts, over 300 online research databases, and has over 10,000 journal subscriptions, the majority of which are available online. During camp, duPont Library will be open from 8:00 a.m. to 5:00 p.m. daily Monday-Friday, with a special opening on the weekend for our program. Learn more at the library website here.

The Center for Speaking & Listening

For part of our time, SUMMA will have full access to the Center for Speaking & Listening (CS&L), housed on the main floor of duPont Library. The CS&L was renovated in 2018 and shares space with the University's writing center. The CS&L includes four semi-private rooms for rehearsal, open space with tables, sofas, and chairs, and computers for conducting research about the debate proposition. SUMMA campers and staff using the library or the CS&L for research and rehearsal should follow all library policies, which can be found here. It is especially important that all SUMMA personnel and attendees respect the space, resources, and staff of the library.

Robert Dobbs Fowler Sport and Fitness Center

The Fowler Sports and Fitness Center is an impressive facility that houses basketball and volleyball courts, an indoor pool, an indoor track, three indoor tennis courts, a weight room, handball and squash courts, and a dance studio. Outdoor facilities include an all-weather track, 10 tennis courts, a nine-hole golf course, and several fields for recreational sports. Equipment is available to borrow at the center. The University Bookstore

The bookstore carries a supply of new and used textbooks, general books, school and office supplies, computer supplies, art supplies, stationery and greeting cards, T-shirts, sweatshirts, caps, and other clothing. Learn more about the bookstore here.

K. Camper Check-list

Be sure to bring the following items:

- Linens—sheets for a long twin bed, pillow and pillowcase, blanket or sleeping bag, towels. (We have use of the dorm's laundry so any items may be washed/dried during camp.)
- Bible (New Revised Standard Version is preferred, but not required)
- Writing materials (notebook, paper, pen, pencils, etc.)
- Laptop (strongly recommended, but optional)
- Casual clothing (shorts, t-shirts, shoes, etc.)
- Dress clothes (e.g., slacks, coat and tie, suit, dress, skirt, or blouse) and appropriate shoes for debate tournaments

- Light sweater, jacket, or sweatshirt
- Pajamas
- Sunscreen and sunglasses
- Rain poncho/jacket and/or umbrella
- Backpack/book bag
- Personal toiletries including soap
- Bug spray
- Any over-the-counter medications listed on the Medical Form
- Any prescription medications listed on the Medical Form

You may consider bringing these items, though they are not necessary:

- Robe/slippers
- Spending money
- Laundry supplies, if needed
- Swimsuit and towel (Note that swimming is allowed at the Fowler Center only when a lifeguard is present—which is not necessarily all days/hours they are open.)
- Sturdy, comfortable hiking shoes
- Sports equipment
- Camera
- Musical instruments
- Props for talent show
