PLEASE READ CAREFULLY. BY SIGNING THIS DOCUMENT, YOU WAIVE CERTAIN LEGAL RIGHTS, INCLUDING THE RIGHT TO SUE FOR NEGLIGENCE.

1. RELEASEES In this agreement, "Releasees" means Lu'ma Gardens and its owners and operators; Spirit Essence Collective by Tara Diana; Tara Diana; and all event hosts, practitioners, vendors, photographers, contractors, volunteers, employees, agents, representatives, successors and assigns.

2. VOLUNTARY PARTICIPATION AND RISKS I voluntarily attend with my dog and understand that gatherings involving dogs, people, equipment and unfamiliar surroundings carry known and unexpected risks. These include bites, scratches, collisions, falls, leash entanglement, escape, stress, illness transmission, allergic reaction, and injury, death, loss or damage involving me, my dog, another person, another animal or property. I freely accept and assume all such risks.

3. DOG GUARDIAN PROMISES I confirm that I am authorized to handle this dog and that the information I provide is accurate. I have disclosed any known bite history, aggression or significant reactivity. My dog is not showing signs of contagious illness and is reasonably comfortable around people and safely manageable in the presence of other dogs. I will keep my dog with me on a secure leash, prevent interaction with Lu'ma Gardens' animals unless expressly permitted, follow all staff directions, and leave immediately if asked for safety reasons. A muzzle may be required or welcomed but does not replace safe behaviour and control.

4. RELEASE AND WAIVER To the fullest extent permitted by law, I release and forever discharge the Releasees from all claims, demands, actions, damages, costs and liabilities arising from or connected with my or my dog's attendance or participation, including claims arising from NEGLIGENCE, breach of contract, or breach of any duty of care under the British Columbia Occupiers Liability Act. This release does not apply where liability cannot lawfully be excluded.

5. INDEMNITY AND RESPONSIBILITY I accept full responsibility for my dog's conduct and for all veterinary, medical, cleaning, repair or replacement costs arising from my or my dog's actions. I agree to indemnify and hold harmless the Releasees from third-party claims, losses, expenses and reasonable legal costs caused by or connected with my breach of this agreement or the conduct of me or my dog.

6. NATURE OF SERVICES I understand that intuitive readings, animal communication, Reiki and related activities are offered for personal and spiritual enrichment only. They are not medical, psychological, behavioural or veterinary diagnosis or treatment and do not replace care from a qualified professional.

7. ACKNOWLEDGMENT I am at least 19 years old. I have had the opportunity to read this agreement, ask questions and obtain independent advice. I understand that this agreement is binding on me and my heirs, estate, personal representatives and assigns. If any part is unenforceable, the remainder continues in effect. This agreement is governed by the laws of British Columbia.
