## Learn the Lingo

#### DAO – Decentralized Autonomous Organization

With the mass adoption of blockchain technology, a new form of company or organization has become increasingly popular. A decentralized autonomous organization, or DAO, is a company governed in a decentralized manner through blockchain-based smart contracts. The main idea behind DAOs is to give a large community of contributors the ability to participate in its governance and future development.

DAOs operate thanks to a combination of various smart contracts, which allow participants to take an equal part in the decision-making processes inside the organization. Decisions made by the community of stakeholders include how the company will use funding and resources. For the plans and rules of the organization to be accepted, a percentage of the community needs to be in a consensus. This consensus is achieved through a decentralized, distributed blockchain, and each DAO determines the percentage required for a decision to pass.
