**Subject : Inter-Circle Transfer of Inspectors of Posts under Rule 38 of P&T Manual Vol.
IV-Reg.**

Respected Madam,

I am enclosing herewith copy of application dated 15/10/2012 received from **Sushil Kumar, Sub Divisional Inspector (South) Pauri Division, Uttarakhand** belonging to 2008 batch working in Uttarakhand Circle and sought transfer under Rule 38 of P&T Manual Vol. IV to Haryana Circle.

The applicant is a surplus candidate of IP examination 2008 and allotted to Uttarakhand Circle. He has already applied for Inter-Circle transfer under Rule 38 to Directorate and copies endorsed to CPMsG Uttarakhand and Haryana Circles. The applicant has applied for Inter-Circle on family ground to Haryana Circle where sufficient number of vacancies in Inspector Posts cadre available.

This Association would like to bring to your kind notice that Directorate vide their memo No. A-141-177/2009-SPB-II dated 14th December, 2010 has issued guidelines for Inter-Circle transfer of Inspectors of Posts under Rule 38 of P&T Manual Vol. IV. In the said memo it has stated that minimum service limit is 3 years for surplus qualified IPs and CPMG of the Circle where the IPs are working would be competent to permit such transfer in consultation with the CPMG of the Circle where the transfer is sought for by the individual.

This Association would like to further state that, according to Ministry of Personnel, Public Grievances and Pensions (Department of Personnel and Training) OM No. F.No. 28034/9/2009-Estt(A) dated 30/9/2009 Para No. 4 (vii), the spouse employed under the Central Government may apply to the competent authority and the competent authority may post the said officer to the station or if there is no post in that station to the State where the other spouse is posted.

In view of the above submissions, it is requested to kindly arrange to issue necessary instructions / directions to CPMG Uttarakhand Circle and Haryana Circle to issue Inter-Circle transfer order of above named official immediately.

Hoping for a favourable action and line in reply is requested.
