

Privacy Policy

This Privacy Policy describes the data that Rooving Autoventures(“we”) process to support Clover Jackpot Slots(“App”). It explains our practices concerning the data we collect from you, or that you provide to us, in connection with the App.

Collection of Data

In order to provide you with all functions and services of the App, we may collect the following data from you:

**content you provide to us (if any);
the type, version, brand, operating system,and language of device;
the type and operator of network(Mac address);
device identifiers(such as IDFA, IDFV, GAID);
the time you use the App and the duration of your use; and
behavioral usage of the App.**

All the above data are obtained by you actively providing it to us when using the App, or by us actively collecting it when providing services to you, or by third-party partners sharing it with us.

Use of Data

We only collect your data for:

**performing the services you have requested;
operating and maintain the App;
responding to your inquiries;
tracking and measuring the App performance;
protecting, investigating and preventing unauthorized or illegal activity.**

Data Sharing

We may share your data with third parties in order to do all the things we’ve described above. This might mean sharing that data with:

**Partners who help us run and develop the App;
Any public authority or law enforcement agency (if they ask for it); and/or
To comply with law or regulations, or for possible legal proceedings.**

These third parties with whom we share information will be subject to the same Google rules about handling user privacy as we are.

Retention of Data

We retain your data we collect from you where we have an ongoing legitimate business need to do so (for example, to provide you with a service you have requested or to comply with applicable legal, tax or accounting requirements).

When we have no ongoing legitimate business need to process your data, we will either delete or anonymize it.

Protection of Data

We implement commercially reasonable technical, administrative, and organizational measures designed to protect your data from loss, misuse, and unauthorized access, disclosure, alteration, or destruction. However, no Internet transmission is ever fully secure or error free. Therefore, you should take special care in deciding what data you provide to us.

Third-Party Content

This Privacy Policy applies only to services provided by us. The App may contain links to other SDKs or applications that are not operated or controlled by us (“Third-Party Content”). We are not responsible for Third-Party Content, and we do not investigate, monitor or check the accuracy or completeness of such Third-Party Content. Such third parties may collect data about you. We recommend that you read the privacy policies of these third parties.
