- Internetsites: *Precise description of internet address with date of referring to the website*

Example: UN Millennium Development Goals. <http://www.un.org/millenniumgoals/> 13 Mar 2004

- *For group presentations: Indication of the sources used mutually or individually.*

*References may be given in font size 8 and with line spacing 1.0.

5 selected sources must be annotated as follows:

- *Content classification in a thematic field*
- *Assessment of the sources*

Example: *The reference provided a detailed insight into certain areas (...) of my topic. In particular, the graphical representations of my main topic (...) were very descriptive and led to a better understanding. For the rough overview of the topic, the reference was rather unsuitable.*

How and to what extent was the use of AI helpful during the different stages of the work process?

Which new questions, topics or aspects in the context of my/our topic did come up during the work process?

Which work steps went as planned / better / worse and what consequences do I draw from this for future research?

What remains to be done until the day of the presentation?

Do I / we expect to concern my- / ourselves again with this topic (for example during an apprenticeship or academic studies)?
