## General Information

I do hope that when you commission me you will read my terms of service, and will try to keep 'to the rules' to avoid uncomfortable situations or misunderstandings either from me or you! <3

When you have questions, feel free to send me a note.

## Payment

- I will only start a Line Art, Colored, and Full Shading and Lighting commission after payment has been received.
- Sketches Will be sent to you via email or twitter dms before payment for additional changes and request to be done **(ALL WORK INCLUDING SKETCHES WILL BE WATERMARKED BEFORE PAYMENT TO AVOID STEALING)**
- My Payment option is defaulted to Paypal invoices but if you'd prefer other payment methods, contact me thru Twitter Dm's to discuss further
- **FULL PAYMENT UPFRONT** after the sketch is sent. I can't do IOUs or Over Time Payments (i.e. you send half now and send the rest later)

## Deadlines and waiting times

- I do offer Rush orders which can be done within 5 days, but choosing this option will **not** guarantee a first spot in my commission queue. Prices can be discussed thru email or Twitter DMs.
- For normal commissions (no sketches), please expect a wait time anywhere from a day to 3 months. With my job, I'm simply unable to schedule my drawing times, since it's very irregular. If after the sketch and payment has been received and waiting time exceeded 3 months, I will provide a full refund.
- Sketches waiting time is estimated to be within a day to 2 weeks to make sure I can provide the most in your commission request

## **Refunds**

- If your waiting time for a normal commission would be longer than 3 months, I will offer a full refund.
- If the waiting time for a Rush Order Commission would be longer than 5 days, I will offer a full refund.
- For all commissions, if you really need a refund because, for example, something nasty has come up and you desperately need the money, send me a DM and we'll discuss it!

## **Work In Progress (WIP)**

- I will keep you updated through the commission process but please be patient!
- For normal commissions (i.e. Line Art, Colored, and Full Shading and Lighting), I will always provide a WIP of the sketch that I initially make and send it through dm's; this to check if there are no mistakes!
- If you want more WIPs, you will have to ask for them yourself in advance.

## **Does and don'ts for me**

- I always have the right to decline your commission, without giving my reasons (don't worry, this doesn't really happen often!)
- I am comfortable with drawing mostly anything. Without trouble, I'll draw; humans, furies, orcs, simple backgrounds, young people, hetero/bi/gay/trans/etc, etc...
- The only things that I'm not comfortable with are realistic animal characters, nude, R18+ stuff and more referred to in my commission sheet. I will also not draw anything that has to do with extreme political subjects, extreme gore, vore, fetishes, etc. Basically, if you're not sure, just ask!
- If you're not sure about an idea or design, feel free to ask, I never bite!
- As of writing this I don't stream but in the future as a heads up, I'm allowed to stream the commission, however, I won't stream it if you ask me not to in advance.
- I'm allowed to use the finished artwork in my portfolio and to upload it to my own page.

## **Does and don'ts for you**

- Do communicate with me, and give me details in your note! For Rush Order and normal commissions, I don't mind receiving lots of references for a character; better too many than too little! I also love reading about a character's background and personality, it helps me in getting ideas ;D
- When a commission is finished, you will receive a full HD version of it. However, I **will not** remove the signature at the bottom and I ask you kindly **not** to remove it either. No worries, it won't be in the way of the image or anything! When you buy a traditional artwork like a painting, it will also always contain the artist's signature, right?
- If you post the commission somewhere, please link back to my profile page or to the page where I uploaded the commission.
- You are not allowed to use the commission in any commercial way (e.g. any way that earns you profit in any way), such as selling prints, using the artwork in a game, printing it in an artbook. Of course, you can print it **for yourself**, but in no way are you allowed to re-sell the artwork.
- You are **not** permitted, **under any circumstances**, to use any part of the commissioned artwork for non-fungible tokens (NFTs). Use of the artwork for any advertising or profits associated with non-fungible tokens or cryptocurrency is strictly prohibited.
