I'm thinking about this much harder than I would have this week last year. Before we had a president bent on wrecking the social contract the New Deal established with our parents and grandparents and that said parents and grandparents worked to equalize and strengthen.

# Volunteer Training and CORI Session

We've had a number of people ask recently about volunteering in the RE program, including the youth group and child care! This is excellent news, but it means that we need to hold one of our periodic training sessions covering our Congregational Child Safety policy and classroom procedures on Sunday, November 16th at 11:30 in the Parlor.

We'll also be asking that all volunteers who work with children fill out CORI forms during the training if they have not been CORled with UUSGU or if their CORI was done before October 2022. I know it seems like a pain to have to get CORled in multiple places, but just as we would never share your CORI information with the school system, they don't share theirs with us, either. To be CORled you need to bring a valid drivers' license or other photo identification that includes a unique ID number and signature, like a passport or military ID.
