GENERAL

- By commissioning me, you agree to the following terms. I reserve the right to refuse any commission for any reason.
 - I retain the rights to my artwork, including but not limited to posting the finished commission on my social media and portfolio.
 - If you have privacy concerns (e.g., you do not want the commission posted publicly or it's a surprise gift), please let me know in advance.
 - I reserve the right to refuse service if you have a history of breaking ToS or engaging in harmful behavior.

PAYMENTS

- All payments must be made upfront.
 - The final price may vary depending on the complexity of your character or request.
 - Rush fees will be applied if you require a tight deadline.

REVISIONS

My workflow usually goes like this: Sketch > Flat Colors/General Mood of the entire piece > Rendering/Polishing > Final Submission

- **Sketch Preview:** Major revisions are allowed when I send you the sketch preview.
- **Flat Color/General Mood Preview:** Major changes are also permitted at this stage.
- **Rendering/Polishing:** Major changes can still apply here. You can request updates during this stage, as it typically takes the longest.
- **Final Artwork:** Minor adjustments after completion are allowed at my discretion. However, if the requested change is considered major, an additional fee will apply.

- In total, I'll **allow 3 major changes**; any more and additional fees will apply. So, please be concise with what you want as much as possible.

DEADLINES AND DELIVERY

- The estimated turnaround time is 2–4 weeks, but I may take longer depending on the complexity of the commission, my queue, or irl obligations.
 - If delays occur, I will inform you as soon as possible.

USE

- **Personal Use:** The commissioned artwork is for personal use. You may use it for icons, headers, or personal prints, but you may not profit from it in any way.
 - **Commercial Use:** If you wish to use the artwork commercially (*e.g., merchandise, promotional materials, streaming assets*), additional commercial fees will apply.
 - **Do Not Claim as Your Own:** I retain full rights to my artwork. You may not claim, edit, or redistribute my work without proper credit.
 - **No AI/NFT Usage:** My artwork may not be used for AI training, NFTs, or any blockchain-related projects.

REFUNDS

- No refunds once I begin working on your commission.
 - A full refund will be issued only if I am unable to complete your commission.

COMMUNICATION

- I reply quickly, but if I haven't replied within a few days, feel free to send a follow-up message.
 - I will provide updates only when necessary, but feel free to ask for progress updates!

\$ Design/Auction

General

- By default, all designs sold are for **personal use only** unless otherwise agreed upon. Commercial use requires additional fees (see *Usage & Licensing* below).
 - I retain full rights to my artwork, including but not limited to posting the finished piece/design on my portfolio and social media.
 - If you prefer your commission/design to remain private (e.g., a surprise gift, or due to personal reasons), please let me know in advance.
 - I reserve the right to refuse service if you have a history of breaking ToS or engaging in harmful behavior.

Ownership & Rights

- You may not claim, redistribute, or edit my artwork without proper credit.
 - You may request **minor edits** from me directly (color tweaks, small adjustments).
 - Please always credit me as the **original artist/designer** when reposting or commissioning others to draw/modify the design.

Payment & Auction Rules

- Payments are accepted through **PayPal only**, in **USD**. I will be sending an invoice, so please share your email.
- Please make sure you have the funds ready before placing a bid.
- Payment should be made within **24 hours** from the moment I contact you.
- **Payment Plans** are available for designs **\$100+**. A non-refundable deposit (usually 20–50%) is required, and the remaining balance must be paid within the agreed timeframe.

- If you have any **unresolved balances with me** (e.g., unfinished payment plans), you must settle them before purchasing again.
 - All payments are **non-refundable** once sent, unless I personally cancel the transaction.
 - Any chargeback/dispute without contacting me first will result in immediate blacklisting and revocation of rights to the design.

Usage & Licensing

- **Personal Use (Default):** You may use the design for icons, headers, roleplay, personal stories, or personal prints. You may not profit from it in any way.
 - **Commercial Use:** If you want to use the artwork/design commercially (e.g., merchandise, promotional materials, Vtuber/streaming assets), an additional **+30% of the total price** will be charged.
 - **No AI/NFT Use:** My artwork and designs may **not** be used for AI training, NFTs, or any blockchain-related projects.

Transfer & Reselling

- Once purchased, you must **wait 1 week** before selling/trading/gifting/redesigning the design.
- You may resell the design for **the base price you paid + the value of any additional commissioned artwork** associated with it.
 - Example: If you bought the design for \$50 and commissioned \$100 worth of extra art, you may resell it for \$150 total.
- **If you purchased my design from another seller**, all artwork they commissioned for it resets to **\$0 USD**. You may only resell it for the original base price you paid. Additional resale value can only be added after you commission new artwork for the design.
- **Personal artwork** (art drawn by yourself) does not add resale value unless:

1. You are an **established artist** with commission prices listed publicly, and
 2. The design has been officially commissioned from you by others before.
Otherwise, personal artwork counts as **\$0** toward resale.
- If you acquire my design through **trade/gift**, its monetary value resets to **\$0**. You can only resell it again if you've added your own commissioned artwork.
 - You may redesign the character, but the **original credit must stay intact**.
 - I reserve the right to revoke usage and blacklist buyers who break these ToS.

Design Co-Ownership

- Co-ownership of a design is allowed, but I will **not mediate or involve myself** in any disputes, agreements, or arrangements between co-owners.
- All terms regarding **usage, rights, and profit sharing** must be settled **between the co-owners**.
- When reselling, trading, or gifting a co-owned design, **all co-owners must agree** before the transfer.
- Only one person may officially handle the transaction with me (the "main contact"), but all listed co-owners are still expected to follow my ToS.
- The resale value of the design will still follow my standard rules (base price + commissioned artwork), regardless of how ownership is divided.
- If co-ownership dissolves (e.g., one owner leaves the arrangement), I am not responsible for determining who the "rightful" owner is. It is the responsibility of the co-owners to decide and document that between themselves.
- Any misuse, broken ToS, or blacklisting by **any one co-owner** will result in the **entire ownership being revoked** from all parties involved.
