- Jen Beamer (Claremont Colleges) – Library is not connected to any of their campuses, so they created a Google Form to gather some data from their researchers, including ORCID iDs. Excited about Nelson Memo – research offices are looking to collaborate w/ library. Really focused on workflow.
- Peter Mangiafico (Stanford) – Want to positively ID Stanford researchers who have ORCID iDs, so they did an integration to allow researchers to connect their iDs to Stanford. They connected their profile system to ORCID. For confirmed publications with DOIs, Stanford can now write info to their researchers' records. Did an ad hoc community of practitioners to chat about outreach once every 1-2 months.
