### **Terms of Service**

These terms of service are binding on everyone purchasing a commission of any sort from me. I behold the right to change and edit these terms without notice. By sending payment, the client agrees to the below terms without exception. Questions and further elaboration on these terms can always be given to the client when contacted.

## **Payment**

- The payment is to be sent **only** through PayPal, by an invoice sent by me.
- All displayed prices are not rigid, and I reserve the right to ask to be paid more or less depending on what I'll be drawing.
- I **do not** do refunds unless I can't find the time at all or I have cancelled your commission after not starting on it. Commissions with only sketches will never be refunded. Refunds will be done per invoice on PayPal.
- Refunds will only come from my side, or after discussion.
- **Do not** refund payment or file chargebacks without notifying and/or agreeing to doing so. You **will** be blacklisted and if in relation to purchasing a character from me, said character will be repossessed without compensation.

# Time and process

- I will always try and finish the commissions as soon as possible without quality loss, though I am not the fastest worker when it comes to owed art. By commissioning me, you agree that you will be patient. If you rush me, it is likely I will cancel your commission. You can ask me at most once a day.
- You **must** inform me beforehand if artwork is supposed to be finished within a specific time, so I can tell you whether it is possible or not.
- When commissioning me, you must provide a visual reference for original characters. It is encouraged not to give me watermarked images that cover more than 20% of the body/markings. If you do so, I'll have to ask you to either send me the image without the watermark, remove the watermark or give me a better/different reference.
- Commissioners **may** request work-in-progress screenshots and general updates regarding a piece's status. Please be mindful of how often this is done.

## **Usage**

#### - For normal commissions

- You are allowed to use my art in any non-commercial way.
- You **are not allowed** to copy, reference or in any way redistribute my art.
- If you wish to use my art in a commercial way, this **must** be discussed with me beforehand.
- If uploading to Toyhouse, all my art must be available for me to see.\*
- If uploading the art somewhere **outside** Toyhouse, you **must** credit me appropriately. You do not have to notify me, though it is preferred.

### For adopts

- You **may** change the design as long as it's still recognisable.
- You may not edit the original artwork.
  - This includes drawing over my art/lines to erase/add/etc. additions to the artwork.
  - Hue shifts/alternative palettes are fine.
  - May be allowed only if discussed prior.

- You may not sell it for a higher price unless it comes with extra art.
- You will notify me if you want to trade/co-own an adopt.
- Every time you sell a character I've made/created, you will have to notify me.
- **Always** make the character available for me to see, especially on Toyhouse (my TH is reeves)\*\*.
- Do not put your own TOS on any characters you buy from me (created by me) if this is a TOS that solely allows characters/designs to be resold to the owner of said TOS. Violation of this term will result in blacklisting, voiding of your TOS and repossession of the character without compensation. \*\*\*

### **Blacklist**

These are people that I **do not** want in possession of my art, designs or anything related to me\*. Please respect these as you **will** be added to the blacklist and whatever you resold will be repossessed without compensation when violating this Blacklist.

If you believe I have recently been in contact with someone (whether it be through sales or otherwise) that should warrant a place on a Blacklist, please do notify me as I am not always up to date regarding issues such as these.

Please ONLY include that you would like to appeal and the reason why because your appeal will be cancelled if it contains anything else.
