### Abstract:

The mandate, could actually be considered criminal, a hate crime, intent to do harm, if you assess the results.

The history , concerning, mandated, commitment is straightforward and long. An early date is around the 1800's when Benjamin Franklin stated that it was necessary to address society's supposed challenges, among the commoners. During the 1950's psychiatrists believed the same, committing many, at random, using facetious protocols, fraught concerning deviant approaches, At the height, concerning the Civil Rights Era, there were more protests, concerning implementing civil liberties. The government, to mandate a commitment now had to provide clear proof, concerning, emotional, challenge, danger to self, and others (Burgess, McKeon, n.d.).

Recently, the government has started outsourcing, concerning more outpatient referrals, because a) the federal government does not want to pay, concerning commitments, b), the insurance companies do not want to pay, concerning, commitment, and, c), there is that constant, occurring challenges, representation, concerning, fair treatment, concerning the poor, and "People of Color", because of inappropriate assessments, and, bias (Burgess, McKeown, n. d). The United States is a diverse society that has values that, historically have been misrepresented, needing reflecting, concerning misdiagnoses, concerning challenges, like, Schizophrenia, and, mood challenges.

African Americans and Hispanic Americans, for example, are misdiagnosed, more than any other culture. The care, concerns, adhering, concerning, assessment protocols American Counselors' Association's required and aspirational ethics. Rutger's University, 2019). Further, at certain Southern hospitals and agencies, professional bias contributed, concerning mistreatment, and commitment. At Southern agencies, or, hospitals, families, who want concerning, disciplining families, who are no danger, call colleagues and commit. Danger, concerning self, and others is serious. It is something that protects the aggressor and victim. Recently, there has been a movement, among African Americans, concerning, ameliorating the stigma that is associated with, concerning, emotional well-being. Professionals encourage, demand, that our culture discuss family business, what African Americans call, cultural more's, showing vulnerability.

The movement has been good because we give ourselves permission, to be human, to ask, concerning help when we need it, to heal. We know that we do not have to be narcissistic, perfect, or divinity. It is a powerful concept, this new wave (Meadows, 2021). Remember, there is still that history, concerning

discriminatory, bias, concerning, physical, health and emotional health. The views, concerning, different, cultures, are not, at times, appreciated, or, welcomed

Examples are the Syphilis trials and, the Holocaust, experiments. There must be a balance, rules,

And, supervision, concerning, the power, that concerns mandated, commitment We must journey through Reconstruction, or similar eras, where minorities and cultures were locked, brutalized, etc (Center for Disease and Control, n.d.). Between, 1882 and, 1968, American racists falsely imprisoned and lynched, 4, 743, individuals. Two thousand lynchings occurred after an era so prosperous, and congenial, concerning race relations, that the transition still shocks American historians.

Similar, concerning the Civil Rights Era, and, recent, African Americans and, "People of Color", reached new frontiers, concerning education government, and, friendship, among races. Though, the economic spiral, and the Hayes Tilden, election coverage created a dissatisfaction, concerning the power of, "People of Color", and a thirst, concerning satisfying enraged disappointment (National Association for the Advancement of Colored People, n.d.; Perzichilki, 2020). History says that this racism is reflected, concerning, professional, Emotional Health. Benjamin Rush, the founder, concerning the American Psychiatry, a participant, concerning, the Anti-slavery, Movement, a signer of the Constitution, wrote, acknowledging Scientific Racism. They spoke of a condition, named Negritude, a form of Leprosy. At, 1851, Samuel Cartwright, stated that African Americans suffered, concerning, Drapetomania, laziness. He prescribed corporal punishment, concerning the cure. (Perzichilli, 2020)

Institutionalized racism prevailed also, concerning the Civil turmoil, a few decades after the 1940s. Schizophrenia is a passive, challenging, when concerning, Caucasian victims. Recently, when African Americans are misdiagnosed, concerning the challenge, it is considered an aggressive, brain challenge. The previous approaches are not working. African Americans are three times more, probably misdiagnosed, likely to be imprisoned. Finally, hospitalization has compelled teens to avoid seeking treatment when needed after release (Perzichilki, 2020).

Today, at the wake, concerning Floyd and Chauvin's transitions, there are 60 million race, related hate crimes. African American men have a one and 1,000 possibility, concerning, transitioning, at police brutality. And, racism costs the nation two trillion (American Counselors' Association, 2021). America should not create, challenging, "false imprisonment", scenarios that cannot be acknowledged, concerning public scrutiny. Because, concerning, confidentiality, ethics, guides, hospital, psychiatric, staff cannot say who a patient is and if they are there.

Finally, there is that response, concerning Barack O'bama's presidency, that is similar to the panic, concerning the American Reconstruction. Although America is full of Caucasian Americans, who voted O'bama, who are not racist, Americans should note the backlash concerning, Immigration. intervene to release a falsely imprisoned victim. The nature, concerning, professional relational aggression, within group variables, and, between group variables, affect this protocol, concerning a discriminatory way. Administrators, who are subjective, discipline participants, who are not dangerous (Center for Disease and, It is noted, that commitment may prevent aggression, like, school gun violence, etc., there is that domestic and international, history, concerning, false, imprisonment, concerning: Individuals who have different, perceptions, different, genders, different, beliefs, who have different, physical compositions, and, different, social and different, economic experiences.

We must be cautious and discerning when speaking, concerning freedom and civil liberties (Holocaust Encyclopedia, n.d.). Examples are women who initiate commitments because their romantic, male, partner is near the female victim, who they thought, dated them. For example, a counselor journeyed, concerning, vacation area, when her romantic, male, acquaintance, argued, etc. The group followed her, manipulated naive friends and family, and committed her, concerning, attempting, concerning, attending, a conference near their male friends. Detention, that is not monitored, concerning, an ethical, professional approach, could possibly create a liaison to the dangerous pre-Civil Rights Era, the American Reconstruction, or, the Holocaust.

Finally, the professional relational aggression, challenges, possibly could affect the safety, concerning the victim (Rutger's University, 2019)

### Example:

A victim was mandated, concerning a female, who thought that victim had dated her male, romantic, partner. She later committed her again, where the victim was regurgitating blood, confined near her, subjected to eating food and fluids, etc. It was dangerous, scary, and illegal. At the Southern states, the victim's family, angry, distracted, allowed the stalking. A stringent, ethics, protocol, could have prevented the pre-requisite, poor health, that prompted the stay, the stalking, and, it would have prevented the danger, concerning, the abuse, concerning, power. Also, the economic challenges, that, concern, mandated, commitment are questionable. Americans, specifically, African Americans, feel that experiencing emotional challenges, is being incompetent.

The stigma, especially, if confidentiality is breached, concerning professional incompetence, or, professional relational aggression, is extensive. The money, concerning mandated, victims is affected, because the aftermath, outpatient therapy, interferes, concerning professional development, working, etc. The stress, concerning dealing, concerning, false imprisonment, is an emotional stressor. The handcuffs and prison like settings are not appropriate, concerning, corrections, inmates. that have not committed heinous, capital one, crimes, that have been proved, at a truthful way. In addition, recent research is inconclusive, moderate, or, does not work. Finally, the historical context concerning American history suggests that Americans, and our international neighbors think, concerning, implementing, false imprisonment", medical protocols.(Corey, 2019; Perzichilki, 2020).

Suggestions:

Suggestions include using a community, systemic approach, changing organizations, adapting when recent events, or, hate crimes, occur. In addition, implementing Multicultural, competencies, and, noting the success, concerning community organizations, that are not near the very accepting university organizations. Many say plenty, concerning we, idealistic graduates, who are brought from our idealistic, passionate clouds, when we encounter elitism, racism, etc. There should be a plan that watches participants when we join the organization, have challenges, or successes, etc.

And, it is male, at 48.93 percent (Augining Action for Health, 2017). The Louisiana Community Mental Health System has an atrocious reputation. Because of the increased suicidal ideation, rate, 0/0 to 7.1 0/0, the state of New Orleans is attentive, using the police more to intercede. The challenge is that, historically, citizens, and tourists have had their privilege, concerning choosing medical attention, compromised.

Their challenges encompass creating Gestapo environments, where tourists are imprisoned, who have no visible challenge and, using, improper assessments. The challenge is that the behavior is not questioned because the residents have about 5.8 college, training, or, experience, that influence cognizance, concerning assessment challenges, and, ethics, frameworks, (Augining Action for Health, 2017),

### Improper Assessments

The police are an important collaborative association. They have been trained, concerning crisis response, concerning Mental Health needs, an

interesting development. They commit, rather than jail, or, murder, 40 0/0, individuals ( Augining Action for Health, 2017).

Our DSM5-handbook states that the behavior is considered a challenge if it interferes, concerning daily, activities, concerning, several, environments (American Psychological Association, 2016). The community challenges are exacerbated when the choice, concerning, freedom, concerning that state is delivered, concerning this ambiguous, apparently, biased, process. According to the American Counselors' Association, Department of Social Justice, the psychiatric nurses, staff have too much power, need, concerning proper training, concerning, assessment. Examples concern a psychiatric, nurse, from, North Carolina, threatening a patient, that complain about a severe physical ailment, stating that it was, "All in her head"

The complainant discovered that her license had lapsed forty years before that. The counselor journeyed to the midwest, concerning a counselors' conference, regurgitating blood, and other bodily objects, until her throat, and organs were sore (American Counselors' Association, 2018). The New Orleans Behavioral Health Crisis System, 2017, Aligning Action For Health). At 5.8 percent, New Orleans' inhabitants are clearly intelligent. They value physical assessment, History, and the Arts. An assessment concerning the challenge is not their, valuable, common sense, the emotional intelligence that determines success more, it is the treatment, concerning their privileges, at the Mental Health agencies (Ellis, 2005).

In addition, the challenges also include the need, concerning a prevention, that addresses the challenges, concerning the vulnerable. According to a 2017 source, the city does not outsource enough (Aligning Action for Health, (2017). Other sources, older ones, that refer to Katrina, state that, 42 psychiatrists, working there after the hurricane.

The impressive approach concerns the creation of more virtual interactions. When the money is not impressive, we drive less and fellowship less. The state seeks to ameliorate the psychological consequences, concerning more social isolation, that is a consequence of the COVID, pandemic.

The need, concerning, counseling, consultation, services, is exacerbated when referring to, concerning, the post Katrina Hurricane, and the pandemic. The state appears, concerned and respectful, concerning other Helping Professions more. The challenge is that Psychology and Psychiatry, respect the medical perspective, at a way that often is not respectful, concerning the importance of Multiculturalism. Examples are seen during the assessment process, concerning "People of Color".

The efforts that discussed, during the American Counselors' Associations' webinars, Concerning using Multicultural perspectives, when assessing, is slowing, when it was rumored to be created by now. Medication is a great tool, if the collaborator, the client, wants it, concerning the acknowledgement of danger, concerning self and others, approach, when you know the way to There are extra methods that are available when an individual needs it, that are very powerful.(Ali, Adam, David, Ferrell, Forde, Stockton, Ward, (2017). This is an impressive development because many residents are pondering the method, concerning addressing their Mental Health needs.

One tourist, who is a School Counselor, concerning another state, advises, to NEVER, visit their Mental Health facilities, rather visit online. They will falsely imprison you, and will NOT know what they are speaking about! The tourist wore her counseling paraphernalia, during a counseling, annual, conference!


