Gene would like OSCA board to do intro video for Grad students, also check in with ASCA for the same thing. Gene, Laureen and a few grad students attended Evidence-based School Counseling conference. (10-11 March next year) Gene reports bill in legislature changing credits/courses needed for graduation. Also, SOU proposed money allocated for training of staff on behavior concerns. Beth is following bill on need to require suicide prevention training in order for SC to renew TSPC license. Sue shared there has been some interest in school counselors forming a team to propose a bill requiring student/counselor ratio of 250:1. This would be for the next session of Oregon legislature. Gene will follow up with counselors. Some Eastern Oregon districts/rural areas may be hiring behavior specialists to handle parts of SC role, without some of the same credentials. Beth has spoken to superintendents about the need for more school counselors. Districts in outlying areas report difficulty in getting candidates. Erika shared Medford does not have elementary school counselors. Are now hiring assistants for "emotional advocates". What is TSPC doing to address the need for more certified School Counselors?
