Types of Data collected

Among the types of Personal Data that this Application collects, by itself or through third parties, there are: Cookies, Usage Data, geographic position, unique device identifiers for advertising (Google Advertiser ID or IDFA, for example) and various types of Data.

User accounts

Some features of this app require creating an account with username and password. Using real name / email is not mandatory, we recommend using alias names and passwords that are not used on any other accounts. Remember, creating the account is necessary just so we can provide the service you desire (for example our Gold Chest feature).

Non-Collected Data

We do not collect personal or sensitive personal data that could lead to a person being positively identified. Also, we never collect the data about race or ethnic origin, political opinions, religious or philosophical beliefs, trade union memberships, genetic or biometric data, health or mortality, sex life or sexual orientation, unless we are legally required by the court of law to do it.

Third-Party Links

Keep in mind that we are not in control of the data our partner websites collect and share. While we are committed to guarding your privacy and safety in every way possible, if you're leaving our application by clicking on third-party links, personal data they collect is out of our hands. We strongly recommend you read the privacy policies of those sites first.

Any use of Cookies or of other tracking tools by this Application or by the owners of third-party services used by this Application serves the purpose of providing the service required by the User, in addition to any other purposes described in the present document and in the Cookie Policy, if available.

All Data requested by this Application is mandatory and failure to provide this Data may make it impossible for this Application to provide its services. In cases where this Application specifically states that some Data is not mandatory, Users are free not to communicate this Data without any consequences on the availability or the functioning of the service. Users who are uncertain about which Personal Data is mandatory are welcome to contact the Owner.

Mode and place of processing the Data

Methods of processing

Analytics

Hosting and backend infrastructure

This type of service has the purpose of hosting data and files that enable this Application to run and be distributed as well as to provide a ready-made infrastructure to run specific features or parts of this Application. Location-based interactions

Non-continuous geolocation (This Application)

This Application may collect, use, and share User location Data to provide location-based services.

System logs and maintenance

For operation and maintenance purposes, this Application and any third-party services may collect files that record interaction with this Application (System logs) or use for this purpose other Personal Data (such as IP Address).

Information not contained in this policy

The rights of Users

Users have the right, at any time, to know whether their Personal Data has been stored and can consult the Data Controller to learn about their contents and origin, to verify their accuracy or to ask for them to be supplemented, cancelled, updated or corrected, or for their transformation into anonymous format or to block any data held in violation of the law, as well as to oppose their treatment for any and all legitimate reasons. Personal Data (or Data)

Any information regarding a natural person, a legal person, an institution, or an association, which is, or can be, identified, even indirectly, by reference to any other information, including a personal identification number.

Usage Data
