

In Nevada, you can get an abortion-

- Until 24 weeks post fertilization
- Without a mandatory waiting period
- Without parental involvement (if you're a minor)
- Sometimes after 24 weeks
 - To save the pregnant person's life
 - o To preserve the pregnant person's general health (can include mental health)
