Text should be typed in Georgia 11pt font, 1.15 spacing, justified alignment. The manuscript should be essay-style, without bullet points or numbered lists. If numbering is necessary, present it in narrative form like: (1) one, (2) two, and (3) three.

Use of abbreviations is allowed, but the full term must be provided upon first mention, followed by the abbreviation in parentheses. Foreign or regional terms should be formatted in Italic.

Quotations follow a direct citation format. Quotes of less than four lines should be included in-text with quotation marks. Quotes longer than four lines must be in a separate paragraph with 1.25 cm left indentation, single line spacing, 9 pt font, also within quotation marks.

Please ensure citations are accurate and listed in the References section.

This section also discusses whether the findings are consistent or in conflict with previous research, and what new insights they contribute to the field.

This part summarizes the linking the introduction to the analysis and discussion. Additionally, it may also include the possibility for further development based on the research outcomes and future studies (based on findings and discussions) which may also include other recommendations. It is written in paragraph form, not in a listed or numbered format.

REFERENCES

References are formatted according to the APA 7th edition and listed alphabetically, without numbers, and are not separated by source type (e.g., books, online sources, etc.). We recommend using software such as Mendeley, Endnote, or Zotero to manage your references. Sources should be from the last 10 years, with a minimum of 60% of the total sources listed to be from the primary sources (scientific journals).
