EXECUTIVE ORDER N^o 16

Callout of the National Guard and Statements Surrounding State-Federal Action in Regards to Los Angeles Shooting

October 5th, 2021

IN PLAIN ENGLISH

(This section does not constitute a part of the Order)

This Executive Order is designed to update the citizens of the State of Fremont as to ongoing State Governmental Action in regards to the Los Angeles Shootings while also seeking the callout order for the Fremont National Guard.

To the People of Fremont, Greeting:

WHEREAS, a shooting occurred within the State of Fremont in the Los Angeles Metropolitan Area which has resulted in the deaths of five individuals and the injury of 12 within the Los Angeles Union Station.

WHEREAS, a second shooting occurred in the heart of the CBD of the Los Angeles Metropolitan Area resulting in the additional deaths of three other individuals and the injury of seven more.

WHEREAS, the perpetrator of these crimes remains at large within the community and serious state leadership is required to ensure that the perpetrator cannot act again.

NOW, THEREFORE, I, GREGOR_THE_BEGGAR, Governor of the Republic of Fremont and in accordance with the authority vested in me by the Constitution and statutes of Fremont, do hereby order as follows:

Sec. 1. Address to the Citizens of the Republic of Fremont.

- (a) An Address from Governor Gregor_The_Beggar of the Republic of Fremont is to be duly filed into the public record through this Executive Order and is to be printed in newspapers by the order of the Governor of the Republic of Fremont whereupon it is legally viable and upon a pure voluntary basis. This address will additionally be published by the City of Los Angeles to be made fully available with all the resources of that city to the people of the Republic of Fremont.
- (b) The Address in section(a) is to be read as follows;
“To the People of Fremont, the working men and women who continue to make this State great;

I am your Governor Gregor_The_Beggar and over the course of three days, we have seen two acts of terrorism committed within the boundaries of the State by an individual who is a resident of the Republic of Fremont. These callous acts of murder have resulted in the deaths of eight individuals and the wounding of nineteen. I can assure the members of the public that those who have been wounded are being treated at the finest medical establishments and shall have their healthcare needs met by the State.

The individual who has committed these crimes cannot be named beyond description and remains at large within the community. This individual could very well commit these actions again. Due to this, the State requires a strong response in order to tackle the threat however the people of this State must now bow down to terror.

Los Angeles and the People of Fremont have never bowed down to terrorism or other acts of violence which have wished to destabilize our people and our nation. The city itself has been founded on land which was defended by pioneers against foreign threats and the people of

the city have shown enormous resilience throughout our history. We are an enterprising people and a people who want security in our endeavours.

Our State Flag flies the mighty bear of the old land of California which represents defiance, resilience and an unwillingness to bend the knee to threats. The bear stands for caring for its cubs and so too shall my State care for those in the community who are going through these traumatic events.

This Address is being delivered just prior to the working week starting once more and the State Government has utilized the weekend to be able to ensure that the Republic of Fremont is prepared for any future incidents. I have been in contact with officials in the National Guard and we will be setting up a cordon around the City of Los Angeles examining documentation and ensuring that very limited numbers of individuals can enter and leave the city at any given time after undergoing a thorough search. This order will come into effect at the start of the working week and will remain until this crisis is resolved.

We have been in contact with officials in rural policing units and the Community Protection Service to ensure that we can keep a close eye on any individuals who may be suspected of trying to flee the scene of the crime. We have also spoken to Governors across this nation and with officials in Mexico to stand-by in case we have reason to suspect the individual in question has fled across the borders of our State.

Los Angeles specialized police units will be deployed to guard every station and platform within the Los Angeles Metropolitan Area by the authority of myself as the Governor with National Guard assistance being provided where it is needed. Our trains will continue to run on time and we will continue to ensure that it is safe to travel in the Los Angeles train network.

A Full Investigatory process is currently underway in cooperation with the Federal Government to find the individual in question. We have information about his description and his employment and are acting accordingly. There is no indication of whether he is acting alone or operating in a group with any potential foreign interference. While it remains a

theory, the State Government will be in contact with the Kingdom of Tonga due to potential leads which may be provided in this case. This does not mean the suspect is Tongan, we have reason to believe however that there may be some connection.

The People of Fremont are advised fully and totally that we are in a State of Emergency and that the individual who has committed these crimes will be brought to justice. Please return to your work and you can be assured that schools will remain open and that the state will remain open. As my people say, I will become a Cakouterror. The destroyer of Terror.

Sec. 2. Callout of the National Guard of the Republic of Fremont and Deployment Zones of the National Guard of the Republic of Fremont.

- (a) aThe National Guard of the Republic of Fremont is called out for service for the duration of two months for the purposes of “ensuring security and safety within the Los Angeles Metropolitan Area”
- (b) The National Guard of the Republic of Fremont will be allowed to be ordered for protective service functions within the boundaries of the Republic of Fremont per the instructions of National Guard ranked officers.
- (c) The National Guard of the Republic of Fremont will set up a cordon around the Los Angeles Metropolitan Area, to be defined by state and federal intelligence services, which will be responsible for the search of individuals and motor vehicles travelling into and out of the Los Angeles Metropolitan Area.
- (d) Section (c) will occur under the powers of a State of Emergency, which this section henceforth declares.

Sec. 3. Functions of the Community Protective Services and Los Angeles Metropolitan Police Force

- (e) The Community Protective Services will have the functions prescribed by the powers of the Governor to “ensure the security of rural Fremont in regards to the Los Angeles Metropolitan Area Shootings and provide relevant protective services to alleviate terror as ordered by National Guard officials.
- (f) The Law Enforcement Agencies within the Los Angeles Metropolitan Area will be ordered to make available relevant personnel and resources for the purposes of providing protection to Los Angeles Train Stations and Train Platforms

Sec. 3. Temporary Injunction on publication of “Joker” Film.

- (a) Due to reasonable suspicion in regards to the motivations of the “Subway Killer”, the Republic of Fremont will be issuing a temporary injunction on the publication of the film “Joker” which State Officials believe may have been a potential motivator.
