# Instructions for accessing and transferring tickets for 2025 NSAA State Wrestling

## **Ticket Invoice:**

Payment will be electronically through Ticketmaster via credit card. The email provided on the order form will be the email used to login to your Ticketmaster account. Once you have paid the invoice, you will receive a confirmation receipt, and the tickets will be visible in your account.

## **Accessing Tickets:**

The link to access your NSAA State Wrestling tickets is <https://am.ticketmaster.com/chi/#/>. The email address associated with your account is the email address you have put on the Ticket Request Form

If you don't already have an account setup, once you enter the site, you will need to click "sign in" (located in the upper right-hand corner) and then click sign up where it says, "new to Ticketmaster?"

Once your account is set up, you will have access to your tickets.

Please note, tickets can only be accessed by using the link above; they cannot be accessed through Ticketmaster.com or the Ticketmaster app. We recommend uploading your tickets into your digital wallet or you can bookmark <https://am.ticketmaster.com/chi/#/>.

## **Transferring Tickets:**

We highly recommend sharing the above instructions to anyone you may transfer tickets to.

When tickets are transferred, the recipient will receive an email letting them know to accept the transfer. The recipient will follow the link and log in or create an account with the email address the tickets were sent to. If tickets to multiple events were sent, there will be a separate email to accept each.

If the recipient already has a Ticketmaster account, they can use the same login information; however, they will only be able to view their tickets for NSAA State wrestling at <https://am.ticketmaster.com/chi/#/>.
