# Weekly Commitments

- Between 70-100 pgs of reading
- 1 page write-up including,
  - A statement of the thesis of the paper
  - A thumbnail sketch of the paper's central argument
  - At least one substantive question or objection per paper
  - At least two connections between the reading and previous work
- 1 hour and a half meeting (Zoom or in-person) in which
  - The student summarizes the author's position and argument.
  - Each substantive question and objection is discussed.

## **Semesterly Commitments**

- The student will construct a weekly reading plan with (a) location, (b) modality, and (c) times the reading will be done. It will include three habits designed to ensure the reading will actually occur (e.g., no phone in reading-zone). This plan is due May 17<sup>th</sup>.
- At the following dates, the elements of a paper project will be due:
  - 1. August 1: Topic Proposal
    - a. At least three paragraphs describing (a) a determinate philosophical question or debate (b) the paper's proposed solution to the question or intervention in the debate, and (c) a full plan for when and how one will work on the rest of the elements of the paper.
  - 2. August 15: Annotated Bibliography
  - 3. August 30: Outline
  - 4. September 15: Complete First Draft
  - 5. Comments returned by Sept. 30
  - 6. October 15: Complete Rewrite
  - 7. October 16-20: Presentation to Faculty
  - 8. October 30: Substantive edits in light of faculty feedback.
  - 9. Nov. 1-Dec 1: Writing feedback, rewrites, and edits.
