Dear Peg, how are you since we last spoke? I'm at WCI no longer on AC however I am currently being deprived of several civil liberties, such as delaying of mail, denying of Law Library access, Mass punishment, staff misconduct. The list goes on, I'm the one who gave Mr Bufford and many others your info to contact you regarding what's going on.

Currently I've sent out numerous letters to my loved ones and for some odd reason nothing has come back and/ or nothing has gotten out to them. the past 3-4 weeks I have been filing ICI after ICI regarding the constant concern for my safety and well-being after being subjected to threats of physical violence by CO Demetrius Reynolds who told me at the beginning of May 2023, the end of April 2023 that he'll beat my ass and that " it won't be a fair fight". The moment I proceeded with informing security and filing a complaint to ICI all of a sudden he began writing me all kind of reports for things I didn't say at all and despite producing facts that he's doing it to further antagonize me and out of retaliation due to me writing him up, the hearing officer still found me guilty and the lieutenant who was supposed to conduct an investigation just up and transferred out of WCI within 2 weeks or less.

I began complaining about the malicious and ill intent of ice rejecting specific complaints in order to keep them " in house" or holding on to complaints for weeks and then rejecting all of them lying saying that they were submitted all in the same day . then (cannot read).That's when my mail started to turn up missing. I haven't been getting my textbehind letters at all. They've got me on back of cell restriction since 5:00 10:23 which was supposed to end 6 9 23 but was extended with no justification at all despite the 30 day policy in which restrictions are supposed to be lifted. I have not been able to use the phone since 5/3/23 to call my family check on my children and now that I just recently filed in 1983 I need to utilize the phone in order to do legal research. WCI has us on lockdown, lying saying that over 40 inmates surrounded RHU and refused to lock in, however the conduct reports do not and will not show this to be the facts because this is a lie. They keep saying we aren't coming off lockdown until they gain compliance- meaning Stand for count, quit fishing and passing-

Despite people having deadlines they are completely refusing to allow us Law Library at all. From the warden on down there telling us that the doc and d a i Administrative Code has been suspended stating they can do whatever they want. I have been trying to get seen by HSU due to my loss of feeling in my hand from being tased twice while cuffed and Shackled and RN Andrea b l e e k e r and asked me if I wanted to be seen I said yes but I was never seen. I keep trying to address my constant fear that the WCI staff are going to cause me bodily harm to no avail. I do not feel safe here Ms Swan now how can I? Inmates are getting stabbed back to back and no Co is doing a damn thing to protect us. I am filing my lawsuits Pro Se and I can't even go to the law library to utilize they need legal Network. Article 5 as well as article 7 of the universal Declaration of Human Rights are being violated. they are lying to the media about this lockdown!! We are on lockdown because the inmates don't stand for count because inmates keep passing and fishing because the inmates are acknowledging their their constitutional rights!! they are stealing our personal property and disposing of it. The alternative to ink pens and are black crayons and now all of a sudden all the Crayons have disappeared. The food they're feeding us is outdated, the water extremely contaminated to the point everyday we're sick but in order to survive we've got to keep drinking and eating. I have PRC coming up in August Miss Swan and I really need to get out of this death trap I fear for my safety.

WCI is the only prison on lockdown why is this Prison still running if it's allegedly so understaffed? There's a scam going on Within These Walls. I need to help before I end up dead in here.
