## **Training Descriptions**

#### **Protecting Personal Data Training**

Everyone needs to understand personal data. Privacy regulations require privacy training for New Hires and as an ongoing requirement. This training satisfies that requirement.

This presentation is geared to the people who work directly with personal data and need to know how to identify personal data and why it is so important to protect personal data. This training works best customized with your organization's specific definitions of personal and sensitive data as well as information from your Employee Handbook, Acceptable Use Policies, Incident Response Plan, and Vendor Management Policy.

- Depending on the level of customization, it is between 18 and 30 slides.
- It works best in a 45-60-minute timeframe.
- Questions are strongly encouraged from the participants.

#### **Privacy by Design Training**

We must include our technical staff in the privacy and data protection conversation. Technical privacy controls are relatively new, and this presentation highlights the universe of technical solutions that can be achieved regardless of policies, procedures, or regulations. There generally is not a lot of customization to this presentation because usually, this is the very first-time teams are learning about technical privacy design strategies and patterns. Depending on the team's understanding of personal data, we can combine some elements from the Personal Data Presentation, i.e., the organization's specific definitions of personal and sensitive data into this training.

• The standard presentation has about 45 slides which can be tailored.



• It is training that works best when interactive, and discussion takes place around the different concepts. We recommend between 90-120 minutes for this training.

#### **Privacy & Data Protection Awareness Training**

This is best for the executive team that makes decisions around data use so they can understand the impact of privacy regulations. It is a high-level review of global privacy with some historical references. It also includes real word examples with breach notification obligations and de-identification techniques. It can be customized with organization-specific regulations, product information, and privacy risk considerations.

- This presentation is usually between 24 and 28 slides.
- We recommend an hour timeslot.

- Legal assessments or contract reviews
- Privacy assessment related to privacy laws or regulations
- Policy reviews
- Security assessment
