Themes, Characters, Theories & Connections of the stories within the tale:

Themes

- Every story mentions certain things:
 - an odd box/package
 - pistachios/pistachio shells
 - Alan Goodtime or some variation of the name Alan (anagrams too)
 - Something to do with a Japanese Maple Tree, leaves, or maple seed pods commonly called “helicopters.” These maple trees are apparently called Japanese bloodgood maples.

- Most stories reveal an object that negatively affects the character and gives Alan control over their fate (For example, the locket in “Yard Sale,” the clock in “One Man’s Trash is Another Man’s Nightmare”). These items pop up in multiple stories, often in the All in Good Time shops.

Theories on the connections between stories

- Three stories contain references to events that happened a long time in the past. The oldest would be the diary found by the supervisor in “I Found This In My Supervisor’s Notes.” The diary is dated in the 1930s, and mentions the marriage of a woman named Lana to a french merchant. Then we have the diary found in “Alain Bontemps.” This diary contains that accounts of a detective in 1950s era Louisiana and details a set of murders he investigated up until his death in the 2000s. Finally, we have the story “Who Was My Grandfather?” in which the author explains how his grandpa up and left his grandma in the 1960s. We learn in that story that dear old grandpa went to work for Alan Goodtime, and can assume his death resulted from his breaking of his contract with Alan by contacting Uncle John. Strictly following the diaries and the family’s account of history, it appears that Alan Goodtime (aka M. Bontemps) fled Argentina after his wife Lana’s death and went to Louisiana. There he influenced Audrey and her daughters, and some time after contracted Grandpa to come and work for him.

- I've noticed that the boy Mike later appears as an adult in the story "The Laptop I Found at the Pawn Shop." In that tale, he was murdered by his step daughter Sara. However, there is a Mike in "The Car of my Dreams" story that doesn't seem old enough to be a step dad. In the letter in the book in "All in good Time," the boys reference Pirates of the Caribbean. The movies weren't made until 2003, but the Disney theme park ride has been around since 1967. Either date can fit into know story details considering "Who Was My Grandfather" mentions the grandfather leaving to work for Alan Goodtime in the 1960s, and the journal in 'Alain Bontemps" dates back to the 1950s. At this point, I can't conclusively say where the letter about the boys in "All in Good Time" takes place timewise.

- I've yet to put together a full timeline of how the plot unfolds. I'm not talking about the order in which the stories were posted. I mean the order of the stories in the progression of the plot. It seems that we're not being fed the plot in a linear fashion, rather, the stories are jumping around in time. Think of each separate story (even the separate parts of the serial stories) as CHAPTERS in a book. Some stories may take place simultaneously, but over all there is a plot that starts at one point, and ends at another. It's important to consider that the separate pieces of serial stories (Mr. Poe, Thailand, All in Good time, etc.) are individual chapters because non-serial stories COULD take place between parts of the Serial posts.

- I've tried putting stories in the order of least tally marks to most. So far 5 is the least amount of tallies I've seen. I think this will help put the timeline together, but not construct it fully.

- 1111 Rustic Ridge is referenced in 2 stories. The first is "1111 Rustic Ridge," then again in "Who was my Grandfather. We know that in "1111 Rustic Ridge" Alan offered the author, Rory Woods, the house as long as he agreed to care for the maple trees..... by sacrificing children to it. Finally this address is referenced in "Who was my Grandfather" where we learn the author's Grandfather took off years ago to take a job with Alan Goodtime & Associates. Now that he is dead, Alan is demanding his first-born son (Uncle John) to come to the address. Also, Rory commented on the 3rd installment of the NK series and admits to planting the tree in Alan's yard. I'm of the opinion that the stories fit in time as follows:
 - Roombas Dancing
 - Who Was My Grandfather?
 - 1111 Rustic Ridge

- Samantha seems to have been present during the happenings of “The Sleepover” as a child. As an adult she stumbles onto the yard sale in “YARD SALE: ALL GOOD THINGS! JUST IN TIME!” and also seems to have a connection to the writer of the letter in “I Got a Package.” She also has and uses an iPhone to find the yard sale, which we see pop up in the story “The Modern Mercury.” Furthermore, if the Author of “the Modern Mercury” is the child Davy from Samantha’s story, then it happens way later because Davy is grown up. ALSO, Eleanor died in a boating accident. :) It’s even possible that “The Sleepover” is one of the earliest stories in the tale, due to Samantha’s growth from child to woman. Other stories could take place in that span of time. Considering this, in order of time, the stories seem to happen:
 - The Sleep Over
 - Yard Sale
 - The Modern Mercury

- “Back in the Alley” takes place after the events in the journal in “Alain Bontemps.” Thus far it seems as though Detective Joe is the blue-suited man who drops the box at the feet of the author in “Back in the Alley.” Both men are dressed similarly and carry revolvers.
 - Alain Bontemps
 - Back In the Alley

- The white mustang makes an appearance in numerous stories, however it is destroyed at the end of the Thailand series, indicating the white mustang stories take place BEFORE the events of Thailand. The stories that include the mustang are(the only point of order so far is that Thailand is the last of them because the car is destroyed):
 -
 - N. K.
 - Alain Bontemps
 - Back in the Alley
 - Help Please, Missing Person Final Update
 - It Found Me In Thailand 2 & 3

- Got a message from a redditor pointing out that the letter writer from “I Got a Package” committed suicide, and that the narrator of “Blood on My Hands” mentions a friend committing suicide in TX. These two stories have strong links to one another. I’m also lead to believe that these events occur after “It Found Me in Thailand” because of the mask.
 - It Found Me in Thailand
 - I Got a Package
 - Blood on my Hands

- The tea set mentioned in “It Found Me in Thailand” is also mentioned in “I Found This In My late Supervisor’s Notes” The second update to “Help, Please! Missing Person” Mentions the death of a man’s wife, and the name Juan. Now, If Juan’s wife is the late supervisor (and I say this because the supervisor states she went BACK to “the south” at the end of the her notes), my opinion on the progression is:
 - It found Me In Thailand
 - Help Please Missing Person 2

- I found this in my LATE Supervisor's Notes.
- "I Couldn't Be Happier" mentions the adoption of a little girl. The details lead me to believe they adopted the missing girl from "Help, please! Missing Person!" I'm also inclined to believe the Eleanor mentioned is the same one plaguing Samantha in "Yard Sale." The Eleanor in "I Couldn't Be Happier" has a son named Davy (Samantha's neighbor.) My theory is that Eleanor possesses Samantha, finds out she can't have kids, and sacrifices Samantha in the scene written in "Car of my Dreams 2." From there she takes Davy, whom she'd grown fond of, and makes her way into the "I Couldn't Be Happier" Tale. If so they order chronologically as follows:
 - Yard Sale!
 - The Car of my Dreams
 - Help, Please! MISSING PERSON!
 - I Couldn't be Happier
- While we're mentioning "Yard Sale!" it's important to note that Samantha was sold a locket by a girl named Allie.... Allie is the narrator of "It Found Me in Thailand." We know at the end of "It found me in Thailand" Allie outsmarted Alan, and killed him. It's plausible to me that she took his place. In order that would be:
 - It Found Me in Thailand
 - Yard Sale!
- In the series "The Death Agreement" Alan Goodtime possess a pocket watch. This has lead me to believe that this means "The Death Agreement" takes place before "It Found Me in Thailand." Allie kills Alan and retains her watch at the end of her story. She also mentions in part one of that Mark seemed alive, so we can postulate that after the events in Thailand that Mark went nuts, became a bum, and was the Mark in "The Traded Briefcase." In order it would look like:
 - The Death Agreement
 - It Found Me in Thailand
 - The traded Briefcase
