- · Changes since budget was emailed out Overdrive is probably increasing; Timesheets is increasing \$4 per month.

- · Workspace in the attic is now extremely user-friendly. Will make working on the Book Sale easier.
- · Discussed talking about previous volunteers who we can ask to help.

Grants Committee (Jane Gabriels, Chair; Sarah Jordan):

- · Received \$3,000 from Charles R. Wood Foundation. We applied for funds to support buying books for the Bolton Central School and Up Yonda. Jane thinks we can maneuver on what we do with this money, possibly supporting both organizations.
- · Should announce with a nice photo of Megan and recipients.
- Encourage kids to drop off/communicate how they felt about the book. Could create an annual field trip to come to the library. Goal is to get kids into the library.
- · Will apply for Adirondack Foundation grant.
- · Stewart's grant available online after Thanksgiving.

- · Megan will amplify getting the grant. Put the logo on the website.
- · Sarah applied for LARAC grant. Would teach a three-session class about Georgia O'Keefe.
- · Sarah applied for Cloudsplitter Foundation grant. Would be used for a sound system. Phone meeting with Cloudsplitter on December 12.
- · SALS Challenge Grant is opening. Can apply for up to \$5,000 for a project and use it for repairs, painting, carpeting.
- · Cloudsplitter will also help with electric and heating oil bills. One of the few grants that supports operating expenses.

- · Met with Megan for her annual evaluation.
- · Agreed on 5 percent cost-of-living salary increase for both Megan and Sarah.
- · Bonnie Baker, who cleans the library, had her salary increased to \$20 per hour.
- · Plan to review and update Megan's job description in 2023. Make it look the same as the Assistant Library job description.
