Abstract. The abstract should be written in one paragraph and should be not more than 250 words. Garamond, font size 10, single spacing. Follow the following pattern: General statement about the importance of the topic, gap in literature or discrepancies between theories and practices, purpose of study, method, main findings, and result. **Abstract must be written in English**

Keywords: Keywords 1; Keywords 2; Keywords 3.

Introduction (Garamond, Font 14)

In Introduction, Authors should state the objectives of the work at the end of the introduction section. Before the objective, Authors should provide an adequate background, and theoretical frameworks which are used in order to discuss the problems as the objective of the research to show which is the best of previous researches, to show the main limitation of the previous researches, to show what do you hope to achieve (to solve the limitation), and to show the scientific merit or novelties of the paper. Avoid a detailed literature survey or a summary of the results. The article should be between 10-13 pages, single spaced, 11 point Garamond font, excluding references and appendices. Use no indent for the first paragraphs and do not leave a space between paragraphs. The following paragraphs is indented first line 1.25cm.

- Heading/Introduction, (14 pt Garamond, Bold, Align Left)
- Body (11 pt Garamond, justify, single spacing 1.pt)

Concept and Hypothesis (Garamond, Font 14)

In Concept and Hypothesis, Authors should state the concept and hypothesis which is used in the research by a very short literature survey.

- Heading/Concept and Hypothesis, (14 pt Garamond, Bold, Align Left)
- Body (11 pt Garamond, justify, single spacing 1.pt)

Method (Garamond, Font 14)

In Methods, Authors should state the methods which were used in the research by a very short literature survey in order to record the existing solutions/method.

- Heading/Method, (14 pt Garamond, Bold, Align Left)
- Body (11 pt Garamond, justify, single spacing 1.pt)

Result and Discussion

Results should be clear and concise. In the Discussion, it is the most important part of your article. Make the discussion correspond with the finding but do not reiterate the discussion.

- Heading/Introduction, (14 pt Garamond, Bold, Align Left)
- Body (11 pt Garamond, justify, single spacing 1.pt)

Conclusion

Conclusions should answer the objectives of the research. Tells how your work advances the field from the present state of knowledge. Without clear Conclusions, reviewers and readers will find it difficult to judge the work.

- Body (11 pt Garamond, justify, single spacing 1.pt)

Reference

Reference must use APA (American Psychological Association) with minimum reference 25 from primary source like Journal, Proceedings or others primary source. Authors must Used Reference Manager like Mendeley, Zotero, End Note, etc to facilitate in citation. Reference used single spaced, 10-point Garamond font.

Example:

- For Journal: Last Name, First Name. (Years). Title of Research. *Name of Journal*. Volume (Number). Pages. Doi/link
- For Book: Last Name, First Name. (Years). *Name of Book*. City: Publisher




Figure 1. Title
