SECTION 1. TITLE.

This Act may be referred to as the “XXX Funding Bill”

SECTION 2. DEFINITIONS.

- (a) SGA — The term “SGA” shall refer to the Student Government Association of The Johns Hopkins University.
- (b) JHU, Hopkins - The terms “JHU” and “Hopkins” shall refer to the Johns Hopkins University.
- (c) SASH— The term SASH shall refer to the South Asian Students at Hopkins
- (d) SAS— The term SAS shall refer to the South Asian Studies minor committee

SECTION 3. FINDINGS AND PURPOSES.
