

APPLICATION FOR POSTS UNDER UNDERGRADUATE ACADEMIC COUNCIL (UGAC) 2026-27

SPECIFIC ROLE OF THE POSTS FOR APPLICATION

The roles for these positions are liable to change during their tenure if needed. All such changes will be decided upon by the General Secretary of Academic Affairs (UG). A few of the established roles for each are:

1. President, Consulting Core Group - 1 position
2. Head, Data Analytics and Visualization Team - 2 positions
3. Fund Manager, Investment Team - 2 positions

CONSULTING CORE GROUP:

The President of Consulting Core Group shall:

- Oversee the three-tier structure of Advisors, Partners, and Associates, ensuring synergy and smooth execution of initiatives
- Promote awareness of consulting and product management opportunities, fostering a culture of case competition
- Curate and develop structured case-solving resources, establishing training programs for Partners and Associates to enhance learning
- Collaborate with various institute bodies and external stakeholders to organize consulting-related events and mentorship opportunities
- Maintain relations with industry clients and take up select pro bono consulting cases to provide real-world exposure
- Oversee the curation of the CCG casebook, ensuring quality and relevance for case-solving preparation

DATA ANALYTICS AND VISUALIZATION TEAM

The heads shall:

- Strive to collaborate with industry and stakeholders to execute key projects
- Strive to ideate, promote, and execute projects based on institute-specific data
- Promote the team to participate in Data Science and ML-based Hackathons
- Have a vision of their own and harbour initiatives within their assigned domain
- Be highly proactive and resourceful, able to lead the team and achieve the set goals timely

INVESTMENT TEAM

The fund managers shall:

- Lead and manage a team of 12 Analysts and 3 Division Heads to drive industrial collaborations and deliver high-impact projects.
- Organize and conduct seminars, workshops, and mentorship sessions featuring top industry experts
- Provide strategic guidance, expertise, and oversight to ensure the successful execution of projects.
- Look forward to building a student-run fund, raising money, and providing hands-on investing experience to the team members
- Collaborate with other UGAC clubs to provide expertise and explore new projects
- Create and share high-quality finance content (M&A outlooks, Equity research reports, Quantitative Strategies, Industry analysis, etc.)

TEAM STRUCTURE

Below is the tentative organizational structure for each team:

- **Consulting Core Group:** Comprises a President, 5 Advisors, 5 Partners, and 8 Associates
- **DAV Team:** Comprised of 2 team heads and 6 team members (exclusively UG sophomores)
- **Investment Team:** Includes two fund managers, 3 division heads, and 12 analysts

ELIGIBILITY CRITERIA

- The candidate must be a registered UG student of IIT Bombay as of 1st January 2026 and will not complete their programme before 31st March 2027.
- During this tenure, April 2026 – March 2027, candidates can not simultaneously hold more than one official gymkhana post

- No CPI requirement for students without active backlogs. However, students with two or more active backlogs must have a CPI of 7.0 or higher as of 1st January 2026

- **For President, CCG:**

- A. Should have completed a minimum of 5 semesters in the institute
- B. Candidate should also satisfy at least 1 of the following 3 criteria:
 1. Should have been part of any consulting related body in the institute
 2. Should have at least one professional experience in consulting (eg: a past/upcoming summer internship)
 3. Should have competed in more than 3 consulting/product case competitions

- **For Head, DAV Team:**
 - a. Should have completed a minimum of 3 semesters in the institute
- **For Fund Manager, Investment Team:**
 - a. Should have completed at least five semesters in the institute
 - b. Must have been an active member of the Investment Team, either as an Analyst or a Sector Head
 - c. Experience in finance in the form of internships, projects, or certifications is necessary.
