Additionally, please note Eligible Voters at Reorganization Meetings – PCOs

- Only Precinct Committee Officers (PCOs) elected during the primary election on August 6, 2024, are allowed to vote for the chair, vice chair, state committee members, and any representatives the LPO is authorized to send to other Party organizations. They are also the only people eligible to vote on the adoption or amendment of LPO bylaws.
- Any PCOs appointed in 2023 or 2024 were appointed to serve the remainder of a two-year term that ended on November 30, 2024. As of December 1, 2024, the terms of these appointed PCOs will have expired, and our organization cannot (re-)appoint PCOs until after it elects the above officers and votes on bylaws.
