Ivy Academy's Skillern Elementary has contracted two full sized bus through Chattanooga Bus Company. Mr. D'Amico keeps a crew of drivers on hand, currently our Drivers are Katie Williams and Zeda Price whose background checks and driver credentials are included in this report. The bus schedule is posted on our website under the School Life tab, then [Parent Connection](#) tab.

After confirming our enrollment, the bus vendor inputs all the student addresses of families who have opted to participate in school bus transportation, and centralized bus stops are selected in the areas where addresses cluster. As district-wide schools, magnet and charter schools cannot offer curb service, but only cluster bus stops, and only in such a way that we keep the route underneath the 90 minutes while serving the majority of family needs. In TN, transportation is a service offered through board policy, and not a mandatory requirement of schools. If families attend a district-wide school of choice instead of their zoned district school, transportation options are fewer, and they must understand that.

Buses

Buses are entered into PAAMS by the bus vendor.

All buses have the state of TN inspection sticker on the front, as well as the reporting bumper sticker on the back. Photos are randomly taken without warning to the bus vendor. Random inspections occur throughout the school year at a minimum of once per month, not only for stickers but for other essential safety requirements such as lighting.

Security Surveillance

All Chattanooga Bus Company buses are equipped with a dvr system and multiple cameras with audio.

Drivers

All driver credentials are on file in a shared google drive folder that school admin have access to, and all are current as verified by the Director of Transportation periodically throughout the year. All drivers are registered in the Federal Drug and Alcohol Clearinghouse. Documentation provided in the folder and in this report.

Public Reporting

The reporting sticker with the telephone number is on the back of the bus.

The online bus complaint form is active on our website.

We have zero bus complaints to the superintendent this year.

We have had zero accidents this school year.

The annual bus evacuation drill will be conducted in February 2025.
