Statement by Ralph Regenvanu, Vanuatu Minister of Climate Change Adaptation, Meteorology and Geohazards, Energy, Environment, and Disaster Risk Management: *"Greetings to you all from Vanuatu, a small island developing state in the southwest Pacific, where we are currently in a national state of emergency, as a result of being hit three weeks ago by two Category 4 tropical cyclones in less than five days, which for us is an unprecedented weather event"*

consistent with what science tells us is the result of climate change. Right now in my country, thousands of our citizens are dealing with broken homes, destroyed critical infrastructure, and a loss of food crops that are the principal source of sustenance for most. We estimate that the cost of this disaster will exceed half of our annual GDP. We are well and truly in the midst of a continuing climate emergency. So the upcoming UN General Assembly Resolution adoption is an historic initiative to uphold the rule of existing international law that aspires States to more holistically and ambitiously address this climate emergency.”
