METHODS OF PAYMENT:

MasterCard, VISA, money orders and certified checks made payable to “Rockland BOCES PN” are allowable forms of payment. Cash or personal checks are not accepted.

INSTALLMENT PLAN:

Tuition balance may be paid in two installments. The First half of the tuition is expected on September 29th and the second half is due on December 31st. Students must sign a payment agreement to initiate the payment plan.

FINANCIAL AID:

Eligible applicants may apply for Federal Student Aid, NYS Higher Education Services Corp. (HESC), 1199 Service Employees International Union (SEIU), CSEA, ACCES-VR or the U.S. Veteran Affairs for tuition assistance.



Eligibility Requirements for Federal Student Aid (FAFSA for Federal PELL Grant & Loans):

- Have a high school transcript or state-approved high school equivalency credential or an foreign diploma stating secondary education is equivalent to U.S. high school education.
- Must be U.S. citizen or eligible non-citizen.
- Enrolled in the Practical Nursing Program.
- Have no defaulted federal education loans.
- Note: Only undergraduates are eligible for Pell Grants.

****Refund Policy for Students Who Withdraw on or Before the First Day of Class:**

If fees are collected in advance of the start date of class and a student decides to drop this course before the first day of class, Rockland BOCES will return the lab, NLN (National League of Nursing) test, and background screening fees. A student's early withdrawal must be submitted in writing to the Practical Nursing Office no later than the first day of class.



Tuition refunds, when due, will be made upon written request from the student. All fees associated with the lab, NLN test, and background screening are refundable if withdrawals are received prior to the start date of class and submitted to the Financial Aid Counselor. The administrative fee will not be refunded.

The Federal Student Aid Title IV Refund Policy and Procedures will be followed as mandated by Federal Law. Contact the Practical Nursing Office at 845-627-4830 for further details of the refund policy of Federal Student Aid and R2T4 calculation.

Refund Policy:

The amount of tuition refund is prorated based on the amount of class time completed and is processed within 45 days of the last day of attendance. Once a student completes 60% of the hours in any given pay period, there are no refunds given.

Refunds for Class Cancellation by Rockland BOCES

If tuition and fees are collected in advance of the start date of the Practical Nursing Program, and Rockland BOCES cancels the class, 100% of the tuition and fees collected in advance will be refunded. The refund shall be made within 45 days of the planned start date.
