Please complete the following steps and <u>submit the completed background checks</u> in the appropriate section of the REDCap form.

### **Instructions for Six Clearances:**

- 1. Child Abuse History Clearance: https://www.compass.state.pa.us/cwis/public/home
  - 1) Create an individual login on the PA Child Welfare Portal
  - 2) Verify your account and proceed with the free application
  - 3) Click create clearance application
    - a) Free application available for volunteers every 52 months→ Select this option if you haven't used this service previously
    - b) There is a small fee if you've used the service previously
  - 4) Fill out the appropriate information: SSN, Previous addresses, etc.
    - a) There is an option to have a paper copy of your certification sent. We recommend you have a physical copy sent but not necessary
  - 5) Await approval and save any corresponding emails for your records

# 2. <u>School Required Background Check OR Pennsylvania State Police Criminal</u> Records Check:

- If you submitted a background check to your graduate program then that is acceptable
- If not, you can fill out the PA State Criminal Record Check here and follow the below steps:

- 1) Click New record check and accept the terms
- 2) Fill Out:
  - a) Organization Name-RISE Philly
  - b) Organization telephone number: 508-314-2633 (Alex Eaton)

- 3) Once complete run a record check on yourself
- 4) View and save printout by clicking on the Invoice #

#### 3. FBI Fingerprinting Clearance:

- If you have lived in PA for 10+ years you can fill out a Volunteer Affirmation Form instead of needing FBI fingerprinting: https://drive.google.com/file/d/1b S0R4jOQsD1fBewlokK6zGJyDxI1-0e/view
- If you have not lived in PA for that amount of time of time please fill out the following steps to get your FBI fingerprinting:
  - 1) Find nearest locations <a href="https://www.identogo.com/locations">https://www.identogo.com/locations</a>
  - 2) Once selected, choose the digital fingerprinting option and enter service code
    - a) For Pennsylvania students: use code 1KG6ZJ
    - b) For New Jersey students: use code 2F151N
  - 3) Fill in your personal information and follow the on screen prompts to make an appointment
    - a) For employer section, put your medical school as the employer
  - 4) On the day of your appointment bring the appropriate identification materials
    - a) Usually a driver's license, however, we recommend you bring two forms of identifications
  - 5) Price for screening is \$22.60

#### 4. Complete Mandated Reporting Online Trainings (3)

- The School District of Philadelphia has elected to use the SafeSchools online safety training program to train both professional and support staff on school-related safety issues. SafeSchools offers trainings in all facets of school safety issues, and its compliance management system tracks all the training for the district, allowing us to easily demonstrate state and federal compliance with safety mandates. SafeSchools courses have been authored by nationally renowned experts and has been endorsed by a number of school boards and superintendent associations nationwide.
- As an employee who requires safety training, you will need to register with SafeSchools to receive your active assignments.
- First, go to the SafeSchools homepage, <u>www.philasdnondistrict-pa.safeschools.com</u> and click "Register" below the "Login" button. On the next screen you will be prompted to enter the registration key according to your position (**Key: ebee1b6e**). Next you will be prompted to enter some basic information, including a username of your choice, which you will use to login to the system moving forward.

  - PA Act 126 Part 1: Child Abuse and Mandatory Reporting,
  - PA Act 126 Part 2: Educator Discipline Act, Sexual Misconduct and Maintaining Professional Boundaries
  - Youth Suicide: Awareness, Prevention and Postvention
