1. Prices and Payment

● *ALL OF MY WORK IS PAID*

- Since my artwork can be used for personal and commercial use, prices can and will be changed depending on the purpose for the artwork.
 - On average, there will be a 50% - 100% increase in pricing if it is for commercial use, otherwise the price will remain the same.
- Payment is ALWAYS upfront and as of now is sent through **PayPal** ONLY. I will NOT accept any other payment methods.
- Only after the payment is received will I begin the commission. I will NOT start a commission if I do not get the money beforehand.
- Every product created by me is digital and will not be shipped due to them not being physical items.

2. Completion Time

- I will be sending updates frequently to you in relation to how much I work on it. More frequent updates signal me working on it more frequently, and the opposite applies as well (Unfortunately I do sometimes work quickly to the point of maybe sending only one or two updates before the final piece; if this occurs, the refund policy stated further below will have more leniency).
- Depending on the complexity and difficulty of the commission, the time it takes to complete the commission can vary a wide amount. Other factors, such as classes will also apply in the time it takes to finish the commission.
- I try to be as transparent as possible with the time it will take me to finish a commission. If you feel as if I am taking too long to complete a commission, please be honest and respectful to me.
- Progress can and will be shared to other places unless stated that you would not like me to do this.
- My DMs are always open to questions you have during the designing process.

3. Changes and Alterations

- Simply put, any changes and alterations requested from the commissioner can increase the charge depending on the severity of the change, along with how far I am into the artwork where a change is requested.
 - For example, a name change for an Avatar will rarely be charged for. However, a request to change the colors of a design can be charged for.
- Any changes you request because of accidents I made will be free of charge.
- I also have the option to refuse alterations if they are too complex, too unclear, or are requested based on information absent in the commission sheet.

4. Refunds

- The amount of money refunded decreases over time and as I go further into the artwork process. If you request a refund decently early into the design, you are looking at up to a 100% refund. If you request a refund near the end of the artwork process, you could be looking at a 75% refund. If you request a refund after I finish the design, you will only get a 40% - 60% refund. **No exceptions.**

5. Deniance and Blacklist

- A commission request can be declined for numerous reasons. If a commission request is too lackluster, if the request is overly complicated, if the request does not fit my time schedule, or if the request does not abide by my Terms of Service, I have the ability to decline the request.
- If a request is denied, the commissioner will be noticed that their commission will not follow through.
- The commissioner then has the opportunity to edit their commission request before submitting again.
- Please wait at least a week before sending a commission request after being declined. If you send one earlier, I will place it at the end of the line.
- If the commissioner has an offense major enough, they can become blacklisted from my commission form.
 - What this means is that that commissioner will no longer be able to request commissions from me for a period of time or indefinitely.
 - The commissioner will be notified of this, along with how long they will be blacklisted for.
 - The only way to get whitelisted after being blacklisted is time. DO NOT message me asking to be whitelisted. I will ignore you and/or make your blacklist indefinite.

6. Reposting, Usage, and Advertisement

- I have the rights to post any and all artwork I create for commissioners on my social media. However, if you wish for me to not post any designs, I can do so.
 - Any artwork I create for a commissioner CANNOT be converted to NFT(crypto art), or be traded after becoming NFT.
 - Along with the point above, none of my work can be resold unless we agree otherwise.
 - DO NOT use my designs as food for AI.
 - You can post any designs I create **FOR YOU ONLY**
