To maintain a Charter and official recognition as a school organization, the following regulations set up by the San Lorenzo Associated Student Body must be followed:

- 1. A Club Constitution must be filed and approved before charting may begin.
- 2. Membership in the club is restricted to students composed entirely of students enrolled at San Lorenzo High School.
- 3. A minimum of 5 members in the club must be signed up in order to charter.
- 4. A faculty advisor must be present at all club meetings.
- 5. Attendance and minutes should be taken at every meeting and submitted to the Clubs Commissioners at Club Council. Meeting minutes forms are available in E6.
- 6. The purpose of the club (like video gaming, community service, etc.) laid out in the Club Constitution must be maintained meaning, any behavior or activity conducted by members outside of their purpose may result in club suspension.
- 7. All money matters must be handled through the school Finance Technician. Any expenditure must be discussed by your club first and reflected in meeting minutes. Expenditures are then approved by Executive Council through a Student Body Purchase Order which can be obtained from the Student Body Office. Expenditures will be approved with the understanding that only club members can spend finances. The club Advisor must make an appointment with the Finance Technician to set-up and establish a club budget.
- 8. All planned events and fundraisers must be approved by filing an Activities Request that will be approved through the Executive Council and will be reported to the School Operations Council so they may be entered on the Master Calendar. All notices for morning announcements or SLzTV must be signed by the Advisor.
