 - Green band is for CDA product family
 - Publishing "Jan 2024 Version C-CDA SD edition" in May 2024 (slide has 2.1 in recording, if not fixed, it will be Jan 24)
- New cycle that will be repeatable
 - New versions will publish in July
 - Looking at US Core and C-CDA changes affecting CDA

 - Work done for 2.1 may be implemented as "extensions" to 2.0
